1. INTENDED USE

The power tool is intended for driving and drilling through wood, metal, plastics and masonry. Not suitable for professional use.

WARNING: Read this manual and general safety instructions carefully before using the appliance, for your own safety. Your power tool should only be passed on together with these instructions.

2. SAFETY INSTRUCTIONS

2.1 GENERAL POWER TOOL SAFETY WARNINGS

WARNING: Read all safety warnings, instructions, illustrations and specifications provided with this power tool. Failure to follow all instructions listed below may result in electric shock, fire and/or serious injury.

Save all warnings and instructions for future reference. The term "power tool" in the warnings refers to your mains-operated (corded) power tool or battery-operated (cordless) power tool.

- 1) Work area safety
 - a) Keep work area clean and well lit. Cluttered or dark areas invite accidents.
 - b) Do not operate power tools in explosive atmospheres, such as in the presence of flammable liquids, gases or dust. Power tools create sparks which may ignite the dust or fumes.
 - c) Keep children and bystanders away while operating a power tool. Distractions can cause you to lose control.

2) Electrical safety

- a) Power tool plugs must match the outlet. Never modify the plug in any way. Do not use any adapter plugs with earthed (grounded) power tools. Unmodified plugs and matching outlets will reduce risk of electric shock.
- b) Avoid body contact with earthed or grounded surfaces, such as pipes, radiators, ranges and refrigerators. There is an increased risk of electric shock if your body is earthed or grounded.
- c) Do not expose power tools to rain or wet conditions. Water entering a power tool will increase the risk of electric shock.
- d) Do not abuse the cord. Never use the cord for carrying, pulling or unplugging the power tool. Keep cord away from heat, oil, sharp edges or moving parts. Damaged or entangled cords increase the risk of electric shock.
- e) When operating a power tool outdoors, use an extension cord suitable for outdoor use. Use of a cord suitable for outdoor use reduces the risk of electric shock.
- f) If operating a power tool in a damp location is unavoidable, use a residual current device (RCD) protected supply. Use of an RCD reduces the risk of electric shock.

3) Personal safety

- a) Stay alert, watch what you are doing and use common sense when operating a power tool. Do not use a power tool while you are tired or under the influence of drugs, alcohol or medication.

 A moment of inattention while operating power tools may result in serious personal injury.
- **b)** Use personal protective equipment. Always wear eye protection. Protective equipment such as a dust mask, non-skid safety shoes, hard hat or hearing protection used for appropriate conditions will reduce personal injuries.
- c) Prevent unintentional starting. Ensure the switch is in the off-position before connecting to power source and/or battery pack, picking up or carrying the tool. Carrying power tools with your finger on the switch or energising power tools that have the switch on invites accidents.

- d) Remove any adjusting key or wrench before turning the power tool on. A wrench or a key left attached to a rotating part of the power tool may result in personal injury.
- e) Do not overreach. Keep proper footing and balance at all times. This enables better control of the power tool in unexpected situations.
- f) Dress properly. Do not wear loose clothing or jewellery. Keep your hair and clothing away from moving parts. Loose clothes, jewellery or long hair can be caught in moving parts.
- g) If devices are provided for the connection of dust extraction and collection facilities, ensure these are connected and properly used. Use of dust collection can reduce dust-related hazards.
- h) Do not let familiarity gained from frequent use of tools allow you to become complacent and ignore tool safety principles. A careless action can cause severe injury within a fraction of a second.

4) Power tool use and care

- a) Do not force the power tool. Use the correct power tool for your application. The correct power tool will do the job better and safer at the rate for which it was designed.
- b) Do not use the power tool if the switch does not turn it on and off. Any power tool that cannot be controlled with the switch is dangerous and must be repaired.
- c) Disconnect the plug from the power source and/or remove the battery pack, if detachable, from the power tool before making any adjustments, changing accessories, or storing power tools. Such preventive safety measures reduce the risk of starting the power tool accidentally.
- d) Store idle power tools out of the reach of children and do not allow persons unfamiliar with the power tool or these instructions to operate the power tool. Power tools are dangerous in the hands of untrained users.
- e) Maintain power tools and accessories. Check for misalignment or binding of moving parts, breakage of parts and any other condition that may affect the power tool's operation. If damaged, have the power tool repaired before use. Many accidents are caused by poorly maintained power tools.
- **f) Keep cutting tools sharp and clean.** *Properly maintained cutting tools with sharp cutting edges are less likely to bind and are easier to control.*
- g) Use the power tool, accessories and tool bits etc. in accordance with these instructions, taking into account the working conditions and the work to be performed. Use of the power tool for operations different from those intended could result in a hazardous situation.
- h) Keep handles and grasping surfaces dry, clean and free from oil and grease. Slippery handles and grasping surfaces do not allow for safe handling and control of the tool in unexpected situations.

5) Battery tool use and care

- a) Recharge only with the charger specified by the manufacturer. A charger that is suitable for one type of battery pack may create a risk of fire when used with another battery pack.
- b) Use power tools only with specifically designated battery packs. Use of any other battery packs may create a risk of injury and fire.
- c) When battery pack is not in use, keep it away from other metal objects, like paper clips, coins, keys, nails, screws or other small metal objects, that can make a connection from one terminal to another. Shorting the battery terminals together may cause burns or a fire.
- d) Under abusive conditions, liquid may be ejected from the battery; avoid contact. If contact accidentally occurs, flush with water. If liquid contacts eyes, additionally seek medical help. Liquid ejected from the battery may cause irritation or burns.
- e) Do not use a battery pack or tool that is damaged or modified. Damaged or modified batteries may exhibit unpredictable behaviour resulting in fire, explosion or risk of injury.
- f) Do not expose a battery pack or tool to fire or excessive temperature. Exposure to fire or temperature above 130°C may cause explosion.
 - **NOTE:** The temperature 130°C can be replaced by the temperature 265°F.

g) Follow all charging instructions and do not charge the battery pack or tool outside the temperature range specified in the instructions. Charging improperly or at temperatures outside the specified range may damage the battery and increase the risk of fire.

6) Service

- a) Have your power tool serviced by a qualified repair person using only identical replacement parts. This will ensure that the safety of the power tool is maintained.
- **b) Never service damaged battery packs.** Service of battery packs should only be performed by the manufacturer or authorized service providers.

2.2 DRILL SAFETY WARNINGS

- a) Wear ear protectors when impact drilling. Exposure to noise can cause hearing loss.
- b) Use auxiliary handle(s), if supplied with the tool. Loss of control can cause personal injury.
- c) Hold power tool by insulated gripping surfaces, when performing an operation where the cutting accessory may contact hidden wiring. Cutting accessory contacting a "live" wire may make exposed metal parts of the power tool "live" and could give the operator an electric shock.

2.3 SAFETY INSTRUCTIONS WHEN USING LONG DRILL BITS

- a) Never operate at higher speed than the maximum speed rating of the drill bit. At higher speeds, the bit is likely to bend if allowed to rotate freely without contacting the workpiece, resulting in personal injury.
- b) Always start drilling at low speed and with the bit tip in contact with the workpiece. At higher speeds, the bit is likely to bend if allowed to rotate freely without contacting the workpiece, resulting in personal injury.
- c) Apply pressure only in direct line with the bit and do not apply excessive pressure. Bits can bend causing breakage or loss of control, resulting in personal injury.

2.4 SAFETY INSTRUCTIONS FOR BATTERIES AND CHARGER

a) Batteries

- Never attempt to open for any reason.
- Do not store in locations where the temperature may exceed 40°C (104°F).
- Charge only at ambient temperatures between 4°C and 40°C(39.2°F and 104°F).
- Charge only using the charger provided with the tool.
- Store your batteries in a cool dry place (5°C-20°C/41°F-68°F). Never store batteries in discharged state.
- It is better for Li-ion batteries to discharge and reload them regularly (at least 4 times a year). The ideal charge for long-term storage of your Li-ion battery is 40% of capacity.
- When disposing of batteries, follow the instructions given in the section "Protecting the environment".
- Do not cause short circuits. If connection is made between the positive (+) and negative (-) terminal
 directly or via accidental contact with metallic objects, the battery is short circuited and an intense current
 will flow causing heat generation which may lead to casing rupture or fire.
- Do not heat. If batteries are heated to above 100°C (212°F), sealing and insulating separators and other polymer components may be damaged resulting in electrolyte leakage and/or internal short circuiting, leading to heat generation causing rupture or fire. Moreover do not dispose of the batteries in fire, explosion and/or intense burning may result.
- Under extreme conditions, battery leakage may occur. When you notice liquid on the battery, proceed as follows:
 - ✓ Carefully wipe the liquid off using a cloth. Avoid skin contact.

- ✓ In case of skin or eye contact, follow the instructions below:
 - Immediately rinse with water. Neutralize with a mild acid such as lemon juice or vinegar.
 - In case of eye contact, rinse abundantly with clean water for at least 10 minutes. Consult a physician.

Fire hazard! Avoid short-circuiting the contacts of a detached battery. Do not incinerate the battery.

b) Charger

- Use the charger provided with the tool only to charge the battery.
- . Never attempt to charge non-rechargeable batteries.
- Have defective cords replaced immediately.
- Do not expose to water.
- Do not open the charger.
- Do not probe the charger.
- The charger is intended for indoor use only.
- This charger can be used by children aged from 8 years and above and persons with reduced physical, sensory or mental capabilities or lack of experience and knowledge if they have been given supervision or instruction concerning use of the appliance in a safe way and understand the hazards involved.
- Children shall not play with the appliance. Cleaning and user maintenance shall not be made by children without supervision.
- If the supply cord is damaged, it must be replaced by the manufacturer, its service agent or similarly qualified persons in order to avoid a hazard.



4. OPERATING AND DISPLAY ELEMENTS

4.1 QUICK-RELEASE CHUCK

The quick-release chuck allows insertion of accessories.

4.2 TORQUE ADJUSTMENT RING

The torque adjustment ring adjusts the tightening torque on a scale from 1 to 21.

4.3 FUNCTION SETTING RING

The function setting ring is used to select between the functions drill, screwdriver and impact drill.

4.4 SPEED SWITCH

The speed switch allows switching between speed 1 and speed 2.

4.5 DIRECTION OF ROTATION SWITCH

The direction of rotation switch is used to choose the direction of rotation.

- The arrow pointing towards the quick-release chuck allows a clockwise rotation.
- The arrow pointing from the quick-release chuck allows counterclockwise rotation.
- When in the central position, the direction of rotation switch blocks the on / off switch

4.6 LED WORK LIGHT

The LED work light illuminates the work area. The LED work light is turned on and off with the on/off switch.

4.7 ON / OFF SWITCH


The on/off switch turns on the device. The position of the on/off switch determines the speed of rotation. The quick-action chuck rotates at a low rotational speed when the insertion depth is small, and rotates at maximum rotational speed when the insertion depth is maximum.


5. OPERATION

5.1 CHARGING THE BATTERY PACK

IMPORTANT: The battery pack is not fully charged at the factory. Before attempting to charge them, thoroughly read all of the safety instructions.

- To assure that the charger you use are applicable to the battery pack.
- Insert the charger into 220-240V~,50-60Hz outlet. The indicator light (15) become to red light to show the power is connected.
- Insert the battery(12) into the slot of charger(14). Make sure the contact with the charger is correct.
- The indicator light (15) become to green and flash when charging.
- When fully charged, The indicator light (15) become to green light.





- Frequently monitor the charger and battery pack while connected.
- Unplug the charger and disconnect it from the battery pack when finished.
- Allow the battery pack to cool completely before using it.
- Store the charger and battery pack indoors, out of reach of children.



Note: If the battery does not fit properly, disconnect it and confirm that the battery pack is the correct model for this charger as shown on the specification chart. Do not charge any other battery pack or any battery pack that does not securely fit the charger.



NOTE: If battery is hot after continuous use in the tool, allow it to cool down to room temperature before charging. This will extend the life of your batteries.



NOTE: Remove battery pack from charger stand which use your thumb or fingers, press the battery's release button in and pull the battery pack off at the same time.

Battery capacity indicator

There are battery capacity indicators on the battery pack; you can check the capacity status of the battery if you squeeze the button. Before using the machine, please press switch trigger to check if the battery is full enough for properly working.

The 3 LED lights will show the capacity level of the battery.

Inserting and removing the battery.


WARNING: Before making any adjustments ensure this tool is switched off with the direction of rotation selector in the center position


- Remove the battery: press the battery release latch in and at the same time pull the battery pack off.
- To insert the battery, push the battery pack onto the contacts of the tool.

5.2 INSTALL THE HANDLE

Screw the handle into the device

You can screw the handle on the left or right of the device depending on the application.





5.3 INSERT ACCESSORIES

- Open the quick-release chuck by turning it in the + direction.
 Open the quick-release chuck just enough so that the accessory can be inserted without forcing.
- Insert the accessory (drill bit) into the quick-tightening chuck. Make sure the accessory is inserted deep enough to provide sufficient power transmission.
- Turn and tighten the quick-release chuck clockwise.

5.4 REMOVE ACCESSORIES

- Open the quick-release chuck by turning it in the "+" direction.
- Remove the accessory from the quick-release chuck.

5.6 DRILL AND SCREW



WARNING: Risk of injury!

• Install the handle for each drilling and screwing job.



NOTICE: Risk of damage!

- To screw or drill with a large diameter, set the speed switch to speed 1.
- Do not operate the on/off switch and the speed switch simultaneously.

Drill

- Mark the desired location.
- Insert a drill bit
- Put the battery in place
- Adjust the function setting ring
- Press the direction of rotation switch on the arrow pointing to the quick-release chuck.
- Place the drill straight on the marking.
- Lightly press the on / off switch to start the device.
- Press the on / off switch harder to start drilling.
- To stop drilling, release the on / off switch.
- When you have finished working, allow the device and the bit to cool completely.
- Remove the battery.
- Remove the bit.

Screw

- Insert an eartip.
- Install the battery.
- Turn the function adjustment ring.
- Turn the torque adjustment ring.
- Start with a low value and increase it if necessary.
- Set the direction of rotation to the desired direction using the direction of rotation switch.
- Place the bit straight into the slot (s) in the screw.
- Lightly press the on / off switch to start the device.
- If necessary, press the on / off switch harder.
- To stop screwing, release the on / off switch.
- When you have finished working, allow the device and the attachment to cool completely.
- Remove the battery.
- Remove the cap.

5.7 REMEDY A BLOCKAGE

In the event of a blockage, proceed as follows:

- If a bit is stuck, release the on/off switch and remove the bit from the drill hole.
- Check the battery charge status.
- A battery with a low state of charge can cause jamming during drilling. Recharge the battery if necessary.

6. CLEANING AND MAINTENANCE

6.1 CLEANING

Keep the ventilation slots of the machine clean to prevent overheating of the engine.

Regularly clean the machine housing with a soft cloth, preferably after each use.

Keep the ventilation slots free from dust and dirt.

If the dirt does not come off use a soft cloth moistened with soapy water.

Never use solvents such as petrol, alcohol, ammonia water, etc. These solvents may damage the plastic parts.

6.2 MAINTENANCE

Our machines have been designed to operate over a long period of time with a minimum of maintenance. Continuous satisfactory operation depends upon proper machine care and regular cleaning.

- Replacement of consumables.
- The use of non-original parts.
- Breakage of parts following impacts or projections.
- · Accessories breakdowns.
- Defects and their consequences linked to any external cause.
- · Loss of components and loss due to insufficient screwing.
- Cutting components and any damage related to the loosening of parts.
- · Overload or overheating.
- Poor power supply quality: faulty voltage, voltage error, etc.
- Damages resulting from the deprivation of enjoyment of the product during the time necessary for repairs and more generally the costs related to the immobilization of the product.
- The costs of a second opinion established by a third party following an estimate by a SWAP-Europe repair station.
- The use of a product which would show a defect or a breakage which was not the subject of an immediate report and/or repair with the services of SWAP-Europe.
- Deterioration linked to transport and storage*.
- Launchers beyond 90 days.
- Oil, petrol, grease.
- Damages related to the use of non-compliant fuels or lubricants.
- * In accordance with transport legislation, damage related to transport must be declared to carriers within 48 hours maximum after observation by registered letter with acknowledgement of receipt.

This document is a supplement to your notice, a non-exhaustive list.

Attention: All orders must be checked in the presence of the delivery person. In case of refusal by the delivery person, you must simply refuse the delivery and notify your refusal.

Reminder: The reserves do not exclude the notification by registered letter with acknowledgement within 72 hours.

Information: Thermal devices must be wintered each season (service available on the SWAP-Europe site). Batteries must be charged before being stored.
