1. INTENDED USE

This appliance is designed for screwing into wood, plastic and metal. The cutting attachment is designed exclusively for cutting soft materials, such as card and similar materials up to a thickness of 6 mm. Use this product only as described and for the areas of applications specified. The appliance is not intended for commercial use. Any other usage or modification of the appliance is deemed to be improper and carries a significant risk of accidents. The manufacturer accepts no responsibility for damage(s) attributable to misuse.

2. SAFETY INSTRUCTIONS

GENERAL POWER TOOL SAFETY WARNINGS



WARNING: Read all safety warnings, instructions, illustrations and specifications provided with this power tool. *Failure to follow all instructions listed below may result in electric shock, fire and/or serious injury.*

Save all warnings and instructions for future reference.

The term "power tool" in the warnings refers to your mains-operated (corded) power tool or battery-operated (cordless) power tool.

1) Work area safety

- a) **Keep work area clean and well lit.** *Cluttered or dark areas invite accidents.*
- b) **Do not operate power tools in explosive atmospheres, such as in the presence of flammable liquids, gases or dust.** *Power tools create sparks which may ignite the dust or fumes.*
- c) **Keep children and bystanders away while operating a power tool.** *Distractions can cause you to lose control.*

2) Electrical safety

- a) **Power tool plugs must match the outlet. Never modify the plug in any way. Do not use any adapterplugs with earthed (grounded) power tools.** *Unmodified plugs and matching outlets will reduce risk of electric shock.*
- b) **Avoid body contact with earthed or grounded surfaces, such as pipes, radiators, ranges and refrigerators.** *There is an increased risk of electric shock if your body is earthed or grounded.*
- c) **Do not expose power tools to rain or wet conditions.** *Water entering a power tool will increase the risk of electric shock.*
- d) **Do not abuse the cord. Never use the cord for carrying, pulling or unplugging the power tool. Keep cord away from heat, oil, sharp edges or moving parts.** *Damaged or entangled cords increase the risk of electric shock.*
- e) **When operating a power tool outdoors, use an extension cord suitable for outdoor use.** *Use of a cord suitable for outdoor use reduces the risk of electric shock.*
- f) **If operating a power tool in a damp location is unavoidable, use a residual current device (RCD) protected supply.** *Use of an RCD reduces the risk of electric shock.*

3) Personal safety

- a) **Stay alert, watch what you are doing and use common sense when operating a power tool. Do not use a power tool while you are tired or under the influence of drugs,**

alcohol or medication. *A moment of inattention while operating power tools may result in serious personal injury.*

- b) Use personal protective equipment. Always wear eye protection.** *Protective equipment such as a dust mask, non-skid safety shoes, hard hat or hearing protection used for appropriate conditions will reduce personal injuries.*
- c) Prevent unintentional starting. Ensure the switch is in the off-position before connecting to a power source and/or battery pack, picking up or carrying the tool.** *Carrying power tools with your finger on the switch or energising power tools that have the switch on invites accidents.*
- d) Remove any adjusting key or wrench before turning the power tool on.** *A wrench or a key left attached to a rotating part of the power tool may result in personal injury.*
- e) Do not overreach. Keep proper footing and balance at all times.** *This enables better control of the power tool in unexpected situations.*
- f) Dress properly. Do not wear loose clothing or jewelry. Keep your hair and clothing away from moving parts.** *Loose clothes, jewelry or long hair can be caught in moving parts.*
- g) If devices are provided for the connection of dust extraction and collection facilities, ensure these are connected and properly used.** *Use of dust collection can reduce dust-related hazards.*
- h) Do not let familiarity gained from frequent use of tools allow you to become complacent and ignore tool safety principles.** *A careless action can cause severe injury within a fraction of a second.*

4) Power tool use and care

- a) Do not force the power tool. Use the correct power tool for your application.** *The correct power tool will do the job better and safer at the rate for which it was designed.*
- b) Do not use the power tool if the switch does not turn it on and off.** *Any power tool that cannot be controlled with the switch is dangerous and must be repaired.*
- c) Disconnect the plug from the power source and/or remove the battery pack, if detachable, from the power tool before making any adjustments, changing accessories, or storing power tools.** *Such preventive safety measures reduce the risk of starting the power tool accidentally.*
- d) Store idle power tools out of the reach of children and do not allow persons unfamiliar with the power tool or these instructions to operate the power tool.** *Power tools are dangerous in the hands of untrained users.*
- e) Maintain power tools and accessories. Check for misalignment or binding of moving parts, breakage of parts and any other condition that may affect the power tool's operation. If damaged, have the power tool repaired before use.** *Many accidents are caused by poorly maintained power tools.*
- f) Keep cutting tools sharp and clean.** *Properly maintained cutting tools with sharp cutting edges are less likely to bind and are easier to control.*
- g) Use the power tool, accessories and tool bits etc. In accordance with these instructions, taking into account the working conditions and the work to be performed.** *Use of the power tool for operations different from those intended could result in a hazardous situation.*
- h) Keep handles and grasping surfaces dry, clean and free from oil and grease.** *Slippery*

handles and grasping surfaces do not allow for safe handling and control of the tool in unexpected situations.

5) Battery tool use and care

- a) **Recharge only with the charger specified by the manufacturer.** *A charger that is suitable for one type of battery pack may create a risk of fire when used with another battery pack.*
- b) **Use power tools only with specifically designated battery packs.** *Use of any other battery packs may create a risk of injury and fire.*
- c) **When the battery pack is not in use, keep it away from other metal objects, like paper clips, coins, keys, nails, screws or other small metal objects, that can make a connection from one terminal to another.** *Shorting the battery terminals together may cause burns or a fire.*
- d) **Under abusive conditions, liquid may be ejected from the battery; avoid contact. If contact accidentally occurs, flush with water. If liquid contacts eyes, additionally seek medical help.** *Liquid ejected from the battery may cause irritation or burns.*
- e) **Do not use a battery pack or tool that is damaged or modified.** *Damaged or modified batteries may exhibit unpredictable behaviour resulting in fire, explosion or risk of injury.*
- f) **Do not expose a battery pack or tool to fire or excessive temperature.** *Exposure to fire or temperature above 130°C may cause explosion.*
- g) **Follow all charging instructions and do not charge the battery pack or tool outside the temperature range specified in the instructions.** *Charging improperly or at temperatures outside the specified range may damage the battery and increase the risk of fire.*

6) Service

- a) **Have your power tool serviced by a qualified repair person using only identical replacement parts.** *This will ensure that the safety of the power tool is maintained.*
- b) **Never service damaged battery packs.** *Service of battery packs should only be performed by the manufacturer or authorized service providers.*
- c) **Hold the power tool by insulated gripping surfaces, when performing an operation where the cutting accessory may contact hidden wiring.** *Cutting accessory contacting a "live" wire may make exposed metal parts of the power tool "live" and could give the operator an electric shock.*

7) ELECTRICAL SAFETY

- a) Connect the charger only to a 100-240V~ socket.
- b) Load the battery of the screwdriver only with the appropriate charger.
- c) The charger and screwdriver must be protected against moisture!
- d) Do not use the charger outdoors.
- e) In order to protect the batteries from damage, never expose them to temperatures above 50 °C.
- f) Warning: Do not short-circuit the battery or charger contacts.
- g) Repeat positive and negative polarity when recharging the battery.
- h) Do not throw the battery into the fire.





8) ADDITIONAL INSTRUCTIONS FOR CHARGER

- **Use the charger provided with the tool only to charge the battery.**

- Never attempt to charge non-rechargeable batteries.
- Have defective cords replaced immediately.
- Do not expose to water.
- Do not open the charger.
- Do not probe the charger.
- The charger is intended for indoor use only.
- This charger can be used by children aged from 8 years and above and persons with reduced physical, sensory or mental capabilities or lack of experience and knowledge if they have been given supervision or instruction concerning use of the appliance in a safe way and understand the hazards involved.
- Children shall not play with the appliance. Cleaning and user maintenance shall not be made by children without supervision.
- If the supply cord is damaged, it must be replaced by the manufacturer, its service agent or similarly qualified persons in order to avoid a hazard.

⚠ CAUTION: Do not recharge non-rechargeable batteries.

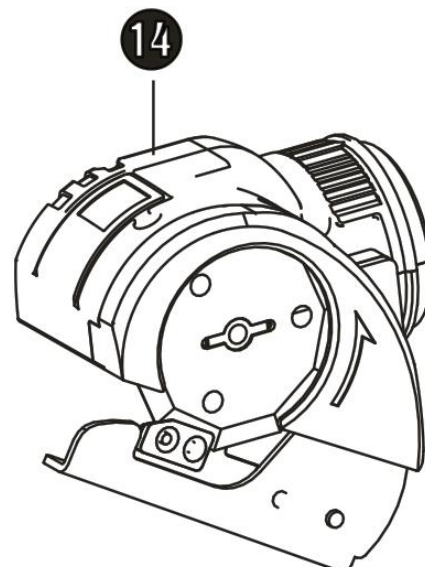
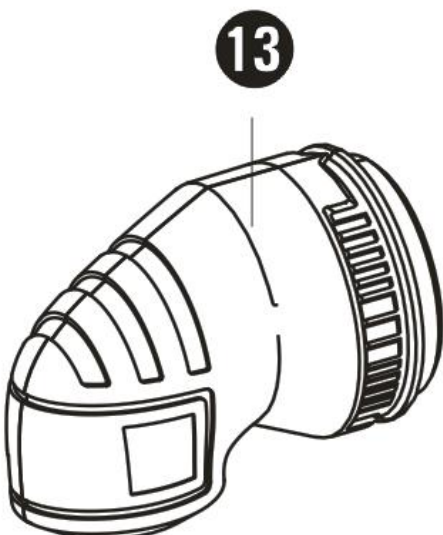
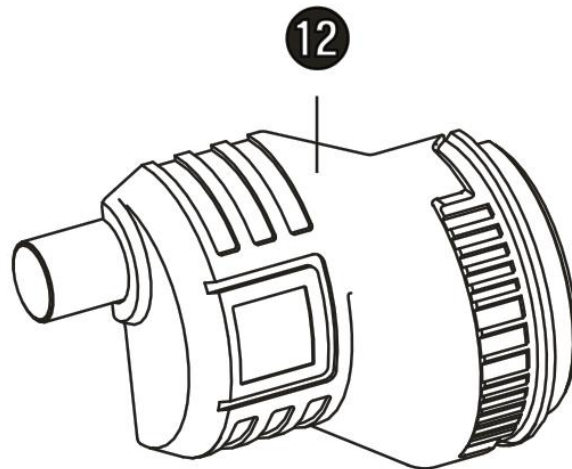
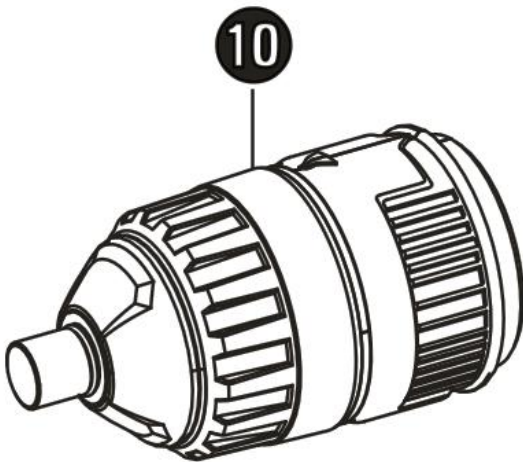
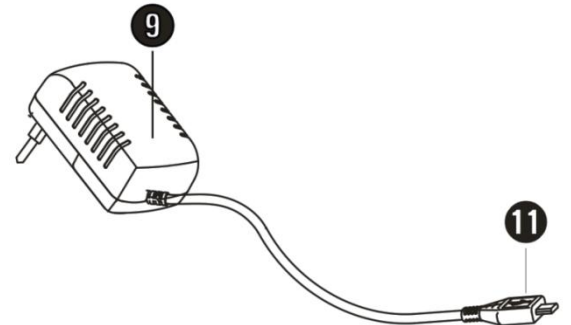
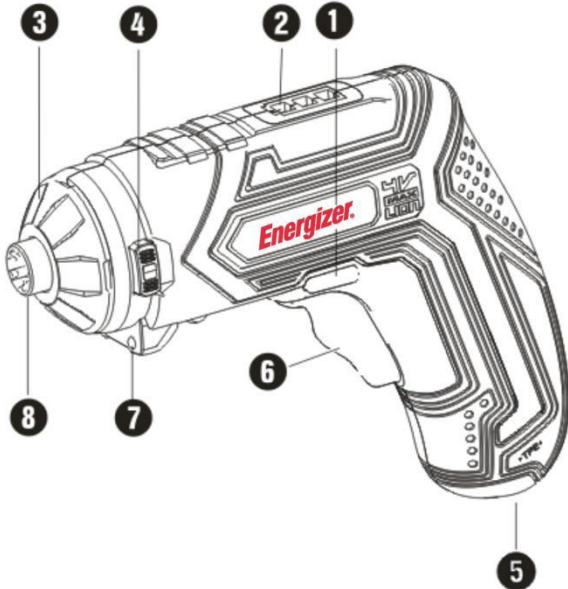

6. BEFORE USE

6.1 Charging the appliance battery (see fig. a)



NOTE:

- The battery is supplied partially charged. Before first use, charge the battery in the charger for at least 1 hour. This guarantees full battery power. Li-ion batteries can be charged at any time without adversely affecting their service life. Interruption of the charging process will not damage the battery.
- If the battery charge level indicator lights up red during use, the battery is at less than 30% of its capacity and needs to be charged.
- Never charge the cordless appliance when the ambient temperature is below 10°C or above 40°C. If a lithium-ion battery is to be stored for an extended period, the charge level should be checked regularly. The optimum charge level is between 50% and 80%. The storage climate should be cool and dry and the ambient temperature should be between 0°C and 50°C.

6.2 Start charging

- Connect the charger to a 100–240 V~ 50/60 Hz power source.
- The battery is fully charged when the battery level display changes from red to green.

6.3 Stopping charging

- Disconnect the charger from the mains power supply.

7. ASSEMBLE THE ATTACHMENTS

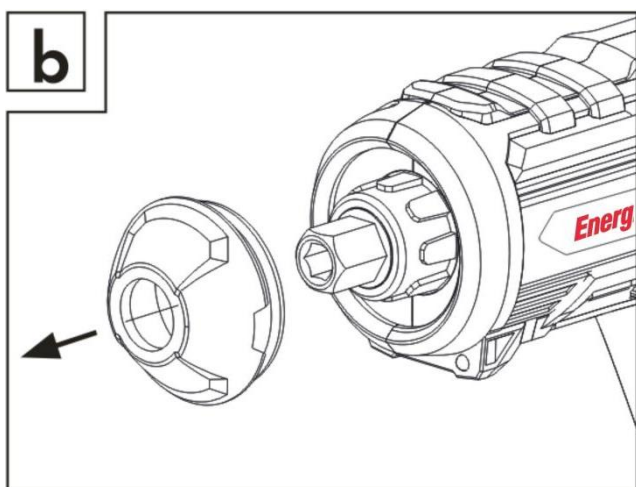
7.1 Usage

- With the torque attachment screwing stops as soon as the screw is tight. Set the required torque from one of the 10 levels.
- The eccentric attachment allows you to screw even in locations that are close to the wall.
- The angle attachment allows you to screw at right angles.
- The cutting attachment allows you to cut soft materials, such as card and similar materials up to a thickness of 6 mm.

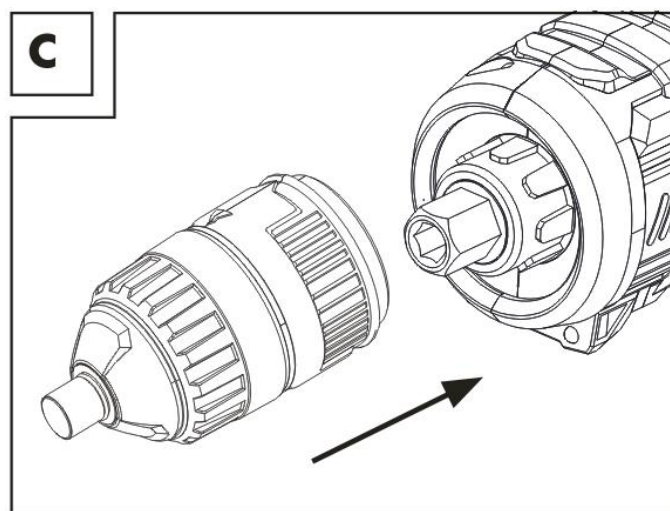
7.2 Assembly

NOTE:

- Before carrying out any work on the appliance, ensure that the rotation direction switch is in the middle. This prevents unintentional switching on.
- Start by removing the rubber cap from the tool holder (see fig. b).



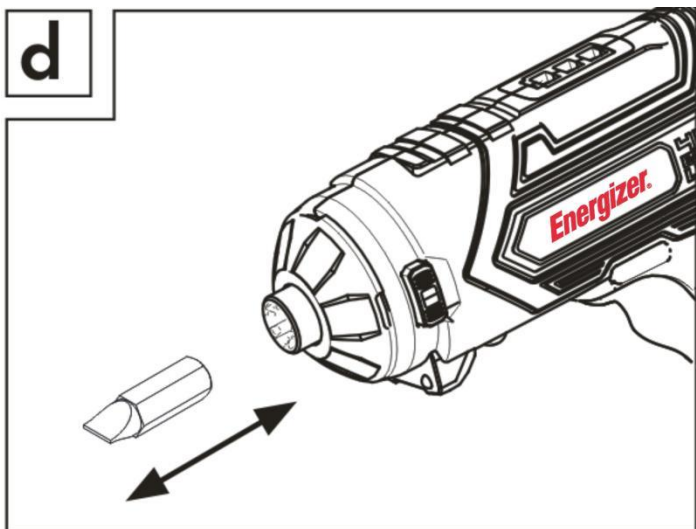
- Now you can fit the supplied attachments to the appliance in 45° steps. Fit the attachment onto the appliance so that the attachment clicks into place. (See fig. C, example: torque attachment).



7.3 Dismantling

- To remove the attachments from the appliance, press the release button and pull the attachment forwards.
- Afterwards, replace the rubber cap on the tool holder.

7.4 Changing bits/screw driver bits (see fig. d)



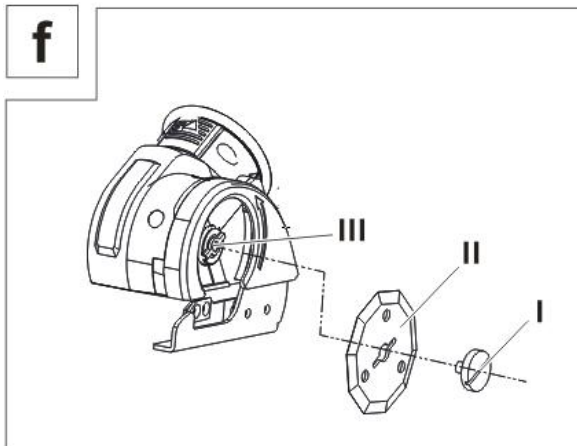
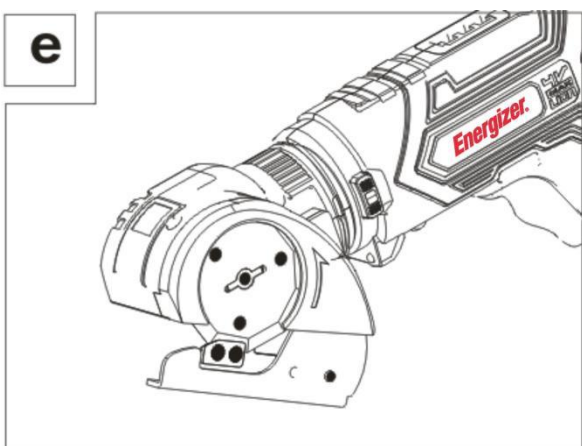
Inserting:

- Insert the bit into the tool holder.

Removal:

- Pull the bit out of the tool holder.


7.5 Replacing the cutting blade (see fig. e + f)



NOTE:

- Before carrying out any work on the appliance, ensure that the rotation direction switch is in the middle. This prevents unintentional switching on.
- Start by connecting the cutting attachment to the appliance. This blocks the motor spindle and allows the screw to be removed.
- Unscrew the screw (I).
- Remove the cutting blade (II) by pulling it downwards.
- Push in a new cutting blade (II) from below ensuring that the ground edge of the blade faces you. Turn around the blade (II) until it fits onto the tool fitting (III).
- Tighten the screw (I).
- The attachment can now be used again.

CAUTION!

- There is an arrow () on the blade guard of the cutting attachment. This shows you the recommended running direction of the cutting blade.

8. OPERATION

8.1 Switching the cordless screwdriver ON/OFF

Switching on:

- To start the appliance, press the ON/OFF switch and keep it pressed in.

Switching off:

- Release the ON/OFF switch to switch off the appliance.

8.2 Changing the direction of rotation

Clockwise:

- Push the rotation direction switch to the left.
- Press the ON/OFF switch, the clockwise rotation; you can now screw in the screws.

Anti-clockwise:

- Push the rotation direction switch to the right.
- Press the ON/OFF switch, the anticlockwise rotation; you can now unscrew the screws.

Safety lock-out:

- Push the rotation direction switch into the middle position. The ON/OFF switch is blocked.

NOTE:

- When the ON/OFF switch is locked it is still possible to activate the LED lamps. To do this, press the ON/OFF switch.

8.3 Tips and tricks

Screw bits are labeled according to their dimensions and their shape. If you are unsure, always try the particular screw bit out to see whether it sits in the screw head without any free play.

9. MAINTENANCE, STORAGE AND CLEANING



WARNING!

RISK OF ELECTRIC SHOCK! Before cleaning, disconnect the charger from the mains socket.

- Before carrying out any work on the appliance, ensure that the rotation direction switch is in the middle. This prevents unintentional switching on.
- The cordless screwdriver is maintenance-free.
- The appliance must always be kept clean, dry and free from oil or grease.
- Never allow liquids to get into the appliance.
- Use a cloth to clean the housing. Never use petrol, solvents or cleansers which can damage plastic.



WARNING!

- Remove the attachments before cleaning. Clean them with a dry cloth.
- Always ensure the appliance and attachments are clean, free of dust and dry before storing.

10. DISPOSAL

THE WARRANTY DOES NOT COVER:

- Start-up and setting up of the product.
- Damage resulting from normal wear and tear of the product.
- Damage resulting from improper use of the product.
- Damage resulting from assembly or start-up not in accordance with the user manual.
- Breakdowns related to carburetion beyond 90 days and fouling of carburetors.
- Periodic and standard maintenance events.
- Actions of modification and dismantling that directly void the warranty.
- Products whose original authentication marking (brand, serial number) has been degraded, altered or withdrawn.
- Replacement of consumables.
- The use of non-original parts.
- Breakage of parts following impacts or projections.
- Accessories breakdowns.
- Defects and their consequences linked to any external cause.
- Loss of components and loss due to insufficient screwing.
- Cutting components and any damage related to the loosening of parts.
