## 1. SAFETY WARNINGS

### **GENERAL POWER TOOL SAFETY WARNINGS**

WARNING Read all safety warnings, instructions, illustrations and specifications provided with this power tool. Failure to follow all instructions listed below may result in electric shock, fire and/or serious injury.

#### Save all warnings and instructions for future reference.

The term "power tool" in the warnings refers to your mains-operated (corded) power tool or battery-operated (cordless) power tool.

- 1) Work area safety
- a) Keep work area clean and well lit. Cluttered or dark areas invite accidents.
- b) Do not operate power tools in explosive atmospheres, such as in the presence of flammable liquids, gases or dust. Power tools create sparks which may ignite the dust or fumes.
- c) Keep children and bystanders away while operating a power tool. Distractions can cause you to lose control.
- 2) Electrical safety
- a) Power tool plugs must match the outlet. Never modify the plug in any way. Do not use any adapter plugs with earthed (grounded) power tools. Unmodified plugs and matching outlets will reduce risk of electric shock.
- b) Avoid body contact with earthed or grounded surfaces, such as pipes, radiators, ranges and refrigerators. There is an increased risk of electric shock if your body is earthed or grounded.
- c) **Do not expose power tools to rain or wet conditions.** Water entering a power tool will increase the risk of electric shock.
- d) Do not abuse the cord. Never use the cord for carrying, pulling or unplugging the power tool. Keep cord away from heat, oil, sharp edges or moving parts. Damaged or entangled cords increase the risk of electric shock.
- e) When operating a power tool outdoors, use an extension cord suitable for outdoor use. Use of a cord suitable for outdoor use reduces the risk of electric shock.
- f) If operating a power tool in a damp location is unavoidable, use a residual current device (RCD) protected supply. Use of an RCD reduces the risk of electric shock.
- 3) Personal safety
- a) Stay alert, watch what you are doing and use common sense when operating a power tool. Do not use a power tool while you are tired or under the influence of drugs, alcohol or medication. A moment of inattention while operating power tools may result in serious personal injury.
- b) **Use personal protective equipment. Always wear eye protection.** Protective equipment such as a dust mask, non-skid safety shoes, hard hat or hearing protection used for appropriate conditions will reduce personal injuries.
- c) Prevent unintentional starting. Ensure the switch is in the off-position before connecting to power source and/or battery pack, picking up or carrying the tool. Carrying power tools with your finger on the switch or energising power tools that have the switch on invites accidents.
- d) **Remove any adjusting key or wrench before turning the power tool on.** A wrench or a key left attached to a rotating part of the power tool may result in personal injury.
- e) **Do not overreach. Keep proper footing and balance at all times.** This enables better control of the power tool in unexpected situations.
- f) Dress properly. Do not wear loose clothing or jewellery. Keep your hair and clothing away from moving parts. Loose clothes, jewellery or long hair can be caught in moving parts.

- g) If devices are provided for the connection of dust extraction and collection facilities, ensure these are connected and properly used. Use of dust collection can reduce dust-related hazards.
- h) Do not let familiarity gained from frequent use of tools allow you to become complacent and ignore tool safety principles. A careless action can cause severe injury within a fraction of a second.
- 4) Power tool use and care
- a) **Do not force the power tool. Use the correct power tool for your application.** The correct power tool will do the job better and safer at the rate for which it was designed.
- b) **Do not use the power tool if the switch does not turn it on and off.** Any power tool that cannot be controlled with the switch is dangerous and must be repaired.
- c) Disconnect the plug from the power source and/or remove the battery pack, if detachable, from the power tool before making any adjustments, changing accessories, or storing power tools. Such preventive safety measures reduce the risk of starting the power tool accidentally.
- d) Store idle power tools out of the reach of children and do not allow persons unfamiliar with the power tool or these instructions to operate the power tool.

Power tools are dangerous in the hands of untrained users.

- e) Maintain power tools and accessories. Check for misalignment or binding of moving parts, breakage of parts and any other condition that may affect the power tool's operation. If damaged, have the power tool repaired before use. Many accidents are caused by poorly maintained power tools.
- f) **Keep cutting tools sharp and clean.** Properly maintained cutting tools with sharp cutting edges are less likely to bind and are easier to control.
- g) Use the power tool, accessories and tool bits etc. in accordance with these instructions, taking into account the working conditions and the work to be performed. Use of the power tool for operations different from those intended could result in a hazardous situation.
- h) **Keep handles and grasping surfaces dry, clean and free from oil and grease.** *Slippery handles and grasping surfaces do not allow for safe handling and control of the tool in unexpected situations.*
- 5) Service
- a) Have your power tool serviced by a qualified repair person using only identical replacement parts. This will ensure that the safety of the power tool is maintained.

### SAFETY INSTRUCTIONS FOR ALL OPERATIONS

Safety Warnings Common for Grinding, Sanding, Wire Brushing, Polishing or Abrasive Cutting-Off Operations

- a) This power tool is intended to function as a grinder or cut-off tool. Read all safety warnings, instructions, illustrations and specifications provided with this power tool. Failure to follow all instructions listed below may result in electric shock, fire and/or serious injury.
- b) Operations such as sanding, wire brushing, polishing are not to be performed with this power tool.

  Operations for which the power tool was not designed may create a hazard and cause personal injury.
- c) Do not use accessories which are not specifically designed and specified by the tool manufacturer. Just because the accessory can be attached to your power tool, it does not assure safe operation.
- d) The rated speed of the accessory must be at least equal to the maximum speed marked on the power tool. Accessories running faster than their rated speed can break and fly apart.
- e) The outside diameter and the thickness of your accessory must be within the capacity rating of your power tool. Incorrectly sized accessories cannot be adequately guarded or controlled.
- f) Threaded mounting of accessories must match the grinder spindle thread. For accessories mounted by flanges, the arbour hole of the accessory must fit the locating diameter of the flange. Accessories that do not match the mounting hardware of the power tool will run out of balance, vibrate excessively and may cause loss of control.
- g) Do not use a damaged accessory. Before each use inspect the accessory such as abrasive wheels for chips and cracks, backing pad for cracks, tear or excess wear, wire brush for loose or cracked wires. If

power tool or accessory is dropped, inspect for damage or install an undamaged accessory. After inspecting and installing an accessory, position yourself and bystanders away from the plane of the rotating accessory and run the power tool at maximum no-load speed for one minute. Damaged accessories will normally break apart during this test time.

- h) Wear personal protective equipment. Depending on application, use face shield, safety goggles or safety glasses. As appropriate, wear dust mask, hearing protectors, gloves and workshop apron capable of stopping small abrasive or workpiece fragments. The eye protection must be capable of stopping flying debris generated by various applications. The dust mask or respirator must be capable of filtrating particles generated by the particular application. Prolonged exposure to high intensity noise may cause hearing loss.
- i) Keep bystanders a safe distance away from work area. Anyone entering the work area must wear personal protective equipment. Fragments of workpiece or of a broken accessory may fly away and cause injury beyond immediate area of operation.
- j) Hold the power tool by insulated gripping surfaces only, when performing an operation where the cutting accessory may contact hidden wiring or its own cord. Cutting accessory contacting a "live" wire may make exposed metal parts of the power tool "live" and could give the operator an electric shock.
- **k) Position the cord clear of the spinning accessory**. *If you lose control, the cord may be cut or snagged and your hand or arm may be pulled into the spinning accessory*.
- I) Never lay the power tool down until the accessory has come to a complete stop. The spinning accessory may grab the surface and pull the power tool out of your control.
- m) Do not run the power tool while carrying it at your side. Accidental contact with the spinning accessory could snag your clothing, pulling the accessory into your body.
- **n) Regularly clean the power tool's air vents**. The motor's fan will draw the dust inside the housing and excessive accumulation of powdered metal may cause electrical hazards.
- o) Do not operate the power tool near flammable materials. Sparks could ignite these materials.
- **p) Do not use accessories that require liquid coolants.** Using water or other liquid coolants may result in electrocution or shock.

### **FURTHER SAFETY INSTRUCTIONS FOR ALL OPERATIONS**

#### **Kickback and Related Warnings**

Kickback is a sudden reaction to a pinched or snagged rotating wheel, backing pad, brush or any other accessory. Pinching or snagging causes rapid stalling of the rotating accessory which in turn causes the uncontrolled power tool to be forced in the direction opposite of the accessory's rotation at the point of the binding.

For example, if an abrasive wheel is snagged or pinched by the workpiece, the edge of the wheel that is entering into the pinch point can dig into the surface of the material causing the wheel to climb out or kick out. The wheel may either jump toward or away from the operator, depending on direction of the wheel's movement at the point of pinching. Abrasive wheels may also break under these conditions.

Kickback is the result of power tool misuse and/or incorrect operating procedures or conditions and can be avoided by taking proper precautions as given below.

- a) Maintain a firm grip on the power tool and position your body and arm to allow you to resist kickback forces. Always use auxiliary handle, if provided, for maximum control over kickback or torque reaction during start-up. The operator can control torque reactions or kickback forces, if proper precautions are taken.
- b) Never place your hand near the rotating accessory. Accessory may kickback over your hand.
- c) Do not position your body in the area where power tool will move if kickback occurs. Kickback will propel the tool in direction opposite to the wheel's movement at the point of snagging.
- d) Use special care when working corners, sharp edges etc. Avoid bouncing and snagging the accessory.

- Corners, sharp edges or bouncing have a tendency to snag the rotating accessory and cause loss of control or kickback.
- e) Do not attach a saw chain woodcarving blade, segmented diamond wheel with a peripheral gap greater than 10mm or toothed saw blade. Such blades create frequent kickback and loss of control.

#### ADDITIONAL SAFETY INSTRUCTIONS FOR GRINDING AND CUTTING-OFF OPERATIONS

Safety Warnings Specific for Grinding and Abrasive Cutting-Off Operation

- a) Use only wheel types that are specified for your power tool and the specific guard designed for the selected wheel. Wheels for which the power tool was not designed cannot be adequately guarded and are unsafe.
- b) The grinding surface of centre depressed wheels must be mounted below the plane of the guard lip. An improperly mounted wheel that projects through the plane of the guard lip cannot be adequately protected.
- c) The guard must be securely attached to the power tool and positioned for maximum safety, so the least amount of wheel is exposed towards the operator. The guard helps to protect the operator from broken wheel fragments, accidental contact with wheel and sparks that could ignite clothing.
- d) Wheels must be used only for specified applications. For example: do not grind with the side of cut-off wheel. Abrasive cut-off wheels are intended for peripheral grinding, side forces applied to these wheels may cause them to shatter.
- e) Always use undamaged wheel flanges that are of correct size and shape for your selected wheel. Proper wheel flanges support the wheel thus reducing the possibility of wheel breakage. Flanges for cut-off wheels may be different from grinding wheel flanges.
- **f) Do not use worn down wheels from larger power tools.** A wheel intended for larger power tool is not suitable for the higher speed of a smaller tool and may burst.

#### ADDITIONAL SAFETY WARNINGS SPECIFIC FOR GRINDING AND CUTTING-OFF OPERATIONS

**Additional Safety Warnings Specific for Abrasive Cutting-Off Operations** 

- a) Do not "jam" the cut-off wheel or apply excessive pressure. Do not attempt to make an excessive depth of cut. Overstressing the wheel increases the loading and susceptibility to twisting or binding of the wheel in the cut and the possibility of kickback or wheel breakage.
- **b) Do not position your body in line with and behind the rotating wheel.** When the wheel, at the point of operation, is moving away from your body, the possible kickback may propel the spinning wheel and the power tool directly at you.
- c) When the wheel is binding or when interrupting a cut for any reason, switch off the power tool and hold it motionless until the wheel comes to a complete stop. Never attempt to remove the cut-off wheel from the cut while the wheel is in motion otherwise kickback may occur. Investigate and take corrective action to eliminate the cause of wheel binding.
- d) Do not restart the cutting operation in the workpiece. Let the wheel reach full speed and carefully re-enter the cut. The wheel may bind, walk up or kickback if the power tool is restarted in the workpiece.
- e) Support panels or any oversized workpiece to minimize the risk of wheel pinching and kickback. Large workpieces tend to sag under their own weight. Supports must be placed under the workpiece near the line of cut and near the edge of the workpiece on both sides of the wheel.
- f) Use extra caution when making a "pocket cut" into existing walls or other blind areas. The protruding wheel may cut gas or water pipes, electrical wiring or objects that can cause kickback.

#### SPECIFIC SAFETY INSTRUCTIONS FOR ANGLE GRINDER

a) When using a cut-off abrasive wheel guard for facial grinding, the wheel guard may interfere with the

- workpiece causing poor control.
- b) When using a grinding wheel guard for cutting-off operating with the bonded abrasive wheels, there is an increased risk of exposure to emitted sparks and particles, as well as exposure to wheel fragments in the events of wheel burst.
- c) Only use the abrasive wheels which are recommended in this manual.

#### **INFORMATION:**

This product is intended for cutting, rough cutting and brushing metal, concrete or tiles without the use of water. Any other uses or modification to the appliance is deemed to be improper usage and may result in serious physical injury. The manufacturer accepts no responsibility for damage(s) attributable to misuse. This product is designed for use by adults and not intended for commercial use.

### **BEFORE THE FIRST USE**

Check if the package is complete and not damaged. If some parts are missed or are damaged, please do not use the tool and bring it back to your dealer.


### **ASSEMBLY**



WARNING: The tool must be always switched off and unplugged before assembly!

#### 1) Installation of the guard

- o Put the protective guard (6) in the correct position (see below Fig. 1).
- o Turn the guard to correct position (see below Fig. 2).
- Screw it firmly the guard. (see below Fig. 3).








#### 2) Installation of the disk(Fig.4)

- Place the inner flange on the spindle.
- Place then the corresponding disk.
- o Place the outer flange the disk and screw it firmly with the pin wrench.
- o Following the disk, the outer flange can be installed on the two sides:



#### 3) Installation of the auxiliary handle

The auxiliary handle can be installed in 3 positions: top of the tool and both sides of the tool. The place where to install the auxiliary handle will depend of the position where you will use the tool. Screw firmly the handle with the provided wrench until it locks in place. See the operation part for install the handle according the position of tool.

### **OPERATION**

- 1) Before switch on the tool, find the correct position to use the tool.
- 2) Plug the supply cord to a socket.

3) Hold the angle grinder by both hands, one hand hold the machine body and the other hold the auxiliary handle.

- 4) Double action to start the machine(Fig.5):
  - i. Press the safety switch (11)
  - ii. Press the ON/OFF switch (1)
- 5) To stop the operation, release the ON/OFF switch (1)

#### Rough grinding

 For the best rough grinding results, hold the grinding wheel at an angle of between 300 and 400 to the work-piece surface and guide back and forth over the work-piece in steady movements.

#### Cutting

When you use the right-angle grinder for cutting



purposes, avoid tilting it in the cutting plane. The cutting wheel must have a clean cutting edge. A diamond cutting wheel is best used to cut hard stone. It is prohibited to use the machine on asbestos materials!


Never use a cutting wheel for rough grinding.

#### Replace the disk (Fig.6)

## A

### WARNING: Beware – a disc which has been used may be very hot!

- 1) Pull out the power plug from the mains socket.
- 2) Depress and hold down the spindle lock button (7) to secure the spindle
- 3) Turn the shaft until it locks.
- 4) Remove the outer flange (a) and backing flange (b) by using the two-hole spanner provided.
- 5) Fit the desired disc (8) on the spindle and replace the outer flange and backing flange. Release the spindle lock.



## 5. REPLACEMENT OF PARTS AND MAINTENANCE

Keep your tool on a regular basis. This will keep your tool in good working order and extend its lifespan. Do not use abrasive or corrosive agents to clean the tool. These types of products damage your tool. Do not make any repairs by yourself. Repairs and inspections should be carried out by a competent person or an authorized service center (please contact your dealer).

#### 1) After each use

Check the condition of the accessories and the tool body (cleanliness, wear, damage, etc.). If you notice any damage, wear or malfunction, do not use the tool and take it to a qualified service for inspection and repair.

#### 2) Servicing

No specific maintenance is required by the user. After each season, please bring the tool to an authorized service center for general machine maintenance.

#### 3) Spare parts

You can order spare parts directly from our service center. Please place your order according to the type of machine and the part number indicated in the explosion drawing.

If the replacement of the supply cord is necessary, this has to be done by the manufacturer or his agent in order to avoid a safety hazard.

#### 4) Storage

After use and cleaning, please keep your tool.

- O Store the tool in a clean, dry place, preferably in its box.
- o When transporting and storing, always put the protective cover on the blade.
- o The tool should be stored away from children and pets.
- Avoid exposing the tool to direct sunlight.

- Damages related to the use of non-compliant fuels or lubricants.

\* In accordance with transport legislation, damage related to transport must be declared to carriers within 48 hours maximum after observation by registered letter with acknowledgement of receipt.

**Attention:** all orders must be checked in the presence of the delivery person. In case of refusal by the delivery person, it you must simply refuse the delivery and notify your refusal.

**Reminder:** the reserves do not exclude the notification by registered letter with acknowledgement within 72 hours.

Thermal devices must be wintered each season (service available on the SWAP-Europe site). Batteries must be charged before being stored.
