1. SAFETY WARNINGS

GENERAL POWER TOOL SAFETY WARNINGS

WARNING Read all safety warnings, instructions, illustrations and specifications provided with this power tool. *Failure to follow all instructions listed below may result in electric shock, fire and/or serious injury.*

Save all warnings and instructions for future reference.

The term "power tool" in the warnings refers to your mains-operated (corded) power tool or battery-operated (cordless) power tool.

1) Work area safety

a) **Keep work area clean and well lit.** *Cluttered or dark areas invite accidents.*

b) **Do not operate power tools in explosive atmospheres, such as in the presence of flammable liquids, gases or dust.** *Power tools create sparks which may ignite the dust or fumes.*

c) **Keep children and bystanders away while operating a power tool.** *Distractions can cause you to lose control.*

2) Electrical safety

a) **Power tool plugs must match the outlet. Never modify the plug in any way. Do not use any adapter plugs with earthed (grounded) power tools.** *Unmodified plugs and matching outlets will reduce risk of electric shock.*

b) **Avoid body contact with earthed or grounded surfaces, such as pipes, radiators, ranges and refrigerators.** *There is an increased risk of electric shock if your body is earthed or grounded.*

c) **Do not expose power tools to rain or wet conditions.** *Water entering a power tool will increase the risk of electric shock.*

d) **Do not abuse the cord. Never use the cord for carrying, pulling or unplugging the power tool. Keep cord away from heat, oil, sharp edges or moving parts.** *Damaged or entangled cords increase the risk of electric shock.*

e) **When operating a power tool outdoors, use an extension cord suitable for outdoor use.** *Use of a cord suitable for outdoor use reduces the risk of electric shock.*

f) **If operating a power tool in a damp location is unavoidable, use a residual current device (RCD) protected supply.** *Use of an RCD reduces the risk of electric shock.*

3) Personal safety

a) **Stay alert, watch what you are doing and use common sense when operating a power tool. Do not use a power tool while you are tired or under the influence of drugs, alcohol or medication.** *A moment of inattention while operating power tools may result in serious personal injury.*

b) **Use personal protective equipment. Always wear eye protection.** *Protective equipment such as a dust mask, non-skid safety shoes, hard hat or hearing protection used for appropriate conditions will reduce personal injuries.*

c) **Prevent unintentional starting. Ensure the switch is in the off-position before connecting to power source and/or battery pack, picking up or carrying the tool.** *Carrying power tools with your finger on the switch or energising power tools that have the switch on invites accidents.*

d) **Remove any adjusting key or wrench before turning the power tool on.** *A wrench or a key left attached to a rotating part of the power tool may result in personal injury.*

e) **Do not overreach. Keep proper footing and balance at all times.** *This enables better control of the power tool in unexpected situations.*

f) **Dress properly. Do not wear loose clothing or jewellery. Keep your hair and clothing away from moving parts.** *Loose clothes, jewellery or long hair can be caught in moving parts.*

g) **If devices are provided for the connection of dust extraction and collection facilities, ensure these are connected and properly used.** *Use of dust collection can reduce dust-related hazards.*

h) **Do not let familiarity gained from frequent use of tools allow you to become complacent and ignore tool safety principles.** *A careless action can cause severe injury within a fraction of a second.*

4) Power tool use and care

a) **Do not force the power tool. Use the correct power tool for your application.** *The correct power tool will do the job better and safer at the rate for which it was designed.*

b) **Do not use the power tool if the switch does not turn it on and off.** *Any power tool that cannot be controlled with the switch is dangerous and must be repaired.*

c) **Disconnect the plug from the power source and/or remove the battery pack, if detachable, from the power tool before making any adjustments, changing accessories, or storing power tools.** *Such preventive safety measures reduce the risk of starting the power tool accidentally.*

d) **Store idle power tools out of the reach of children and do not allow persons unfamiliar with the power tool or these instructions to operate the power tool.**

Power tools are dangerous in the hands of untrained users.

e) **Maintain power tools and accessories. Check for misalignment or binding of moving parts, breakage of parts and any other condition that may affect the power tool's operation. If damaged, have the power tool repaired before use.** *Many accidents are caused by poorly maintained power tools.*

f) **Keep cutting tools sharp and clean.** *Properly maintained cutting tools with sharp cutting edges are less likely to bind and are easier to control.*

g) **Use the power tool, accessories and tool bits etc. in accordance with these instructions, taking into account the working conditions and the work to be performed.** *Use of the power tool for operations different from those intended could result in a hazardous situation.*

h) **Keep handles and grasping surfaces dry, clean and free from oil and grease.** *Slippery handles and grasping surfaces do not allow for safe handling and control of the tool in unexpected situations.*

5) Service

a) **Have your power tool serviced by a qualified repair person using only identical replacement parts.** *This will ensure that the safety of the power tool is maintained.*

SANDER SAFETY WARNINGS

Hold the power tool by insulated gripping surfaces, because the sanding surface may contact its own cord. *Cutting a "live" wire may make exposed metal parts of the power tool "live" and could give the operator an electric shock.*

SPECIFIC SAFETY INSTRUCTIONS FOR SANDER



WARNING! Sander can result in the formation of hazardous dusts (e.g. arising from materials such as paints containing lead, materials containing asbestos, metals or some wood types), which can present a health hazard to the operator or persons in the vicinity if touched or inhaled. Make sure that the workplace is well ventilated. Always wear safety goggles, safety gloves and respiratory protection. Attach a dust extraction system.

1. Secure the workpiece. A workpiece that is retained with clamping appliances or a vice is held more securely than with your hands.
2. Only use the power tool for dry sanding. Do not scrape moist materials. Penetration of water into the power tool increases the risk of electric shock.
3. Avoid overheating the sanded object and the sander itself. Possible fire hazard.
4. The workpiece gets hot during grinding. Do not touch the machined area, allow it to cool down. There is a risk of burning. Do not use coolants or the like.
5. Always empty the dust container before work breaks. Sanding dust in the dust sack, microfilter, paper

sack (or in the filter sack or extraction system filter) can self-ignite under unfavourable conditions such as flying sparks caused by grinding metals. Particular hazards are caused if the sanding dust is mixed with paint, polyurethane residues or other chemical substances, or if the sanded object is hot after long working periods.





6. Please check the operating manual of your vacuum cleaner whether it is suitable for the suction of grinding chips.
7. Connect the appliance to a power socket with a residual current circuit breaker of rated residual current no more than 30mA.
8. Type Y attachment, If the replacement of the supply cord is necessary, this has to be done by the manufacturer or his agent in order to avoid a safety hazard.

RESIDUAL RISK

Even if properly operating and handling this electric tool, some residual risks will remain. Due to its construction and build, this electric tool may present the following hazards,

1. Lung damage, if suitable respiratory protection is not worn;
2. Cuts
3. Ear damage if working without wearing ear protection
4. Eye damage if suitable eyes protection is not worn.
5. Damage to your health caused by swinging your hands and arms when operating the electric tool for longer periods of time or if the too is not held or maintained properly

4. USE

INTENDED USE

- The sander is intended for dry sanding of wood, metal, plastic, plaster and painted surfaces. The sander is not suitable for commercial use.
- The device is designed for use by adults. Adolescents over the age of 16 may use the device only under supervision. The manufacturer is not liable for damages caused by unspecified use or incorrect operation.
- Any other use or modification that is not explicitly approved in these instructions may result in damage to the device and represent a serious danger to the user.

CHANGING & FITTING THE SANDING SHEETS



WARNING: Never use the tool without a sanding sheet or accessory in place.

- 1) Inspect sandpaper before installing; do not use if broken or defective.
- 2) Lift up and unlatch the two clamping levers from both sides of the backing pad. The front and rear clamp wires are then opened and loose.
- 3) Pull Out old sandpaper and clean backing pad. Align the pattern of the sandpaper with the one in the backing pad to ensure efficient dust extraction.
- 4) Place the sandpaper between the clamping wire and backing pad while aligning edges of the sandpaper with either edge of the pad.
- 5) After inserting the sandpaper, raise clamping levers and return it to its original position making sure the clamping wire is secure. The sandpaper must be drawn as tight as possible for efficient sanding, as a loose sandpaper can slip on the work surface.

Remark: Sanding sheet without holes, e.g. from rolls or by the meter, should be cut to suitable size and punctured with holes by user according to the holes on the sanding pad.

SWITCHING ON/OFF

The tool is switched On by the ON/OFF switch located on the top of the tool housing.

- 1) To turn the tool on, push the switch to upwards.
- 2) To turn the tool off, push the switch to downwards.

SPEED DIAL

The sander features 7 speed gear box which allows you to match the proper speed to the material being sanded. The speed dial allows you to increase or decrease the speed from 7,000-13,000 orbits per minute. The optimal speed setting for each application is very much dependent on personal preference. Generally, you will want to use a higher setting on harder materials and a lower setting on softer materials. Material removal rate increases as speed increases.



WARNING: The tool must be turned off before switching speed.

USING THE DUST COLLECTION BOX

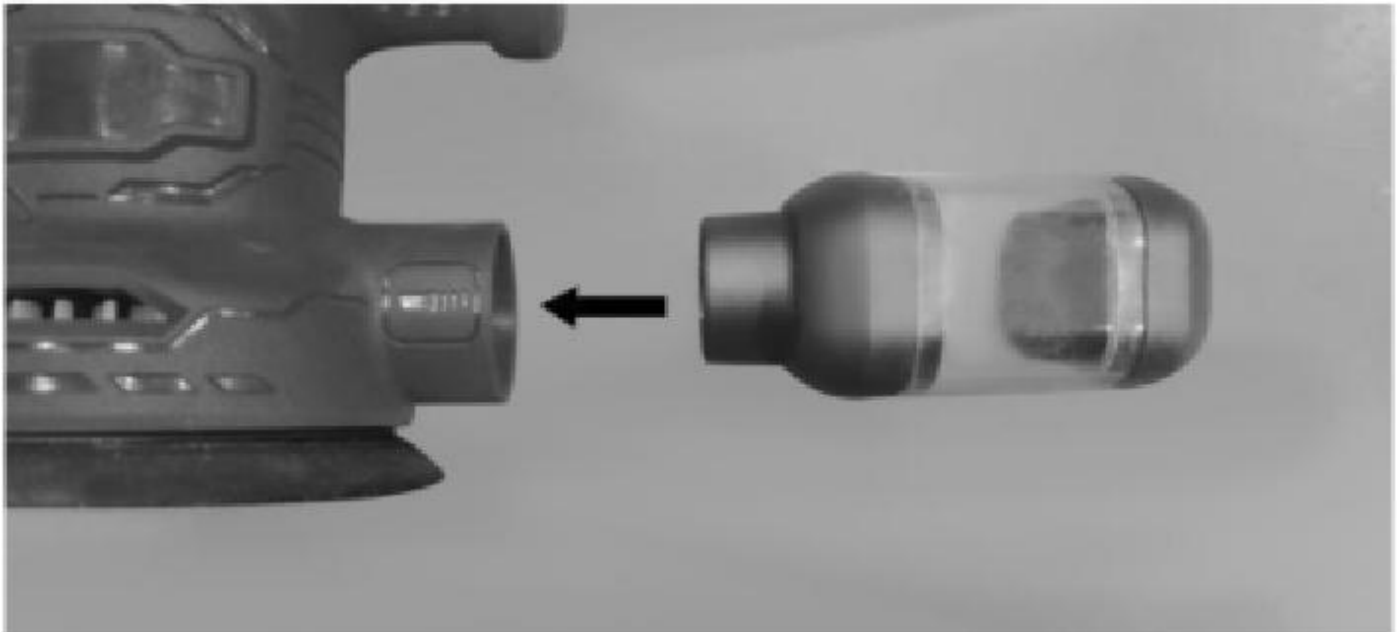
The dust extraction system extracts sanding dust from the work piece through the holes in the backing pad. The dust is then transferred through the dust extraction port on the rear of the sander housing.

- 1) **To install:** users can directly insert the dust box onto the dust extraction port. please make sure the dust bag is tightly fastened.
- 2) **To remove:** When removing the dust box, follow the above procedure in reverse order.

If the dust collection box is full, you can remove it from this tool and open the cover of box, empty dust, wood dust, etc. in the body, finally clean the dust collection box.

⚠️ WARNING: Please empty the dust collection box frequently, after completion of sanding and before storing the sander.

Be extremely careful of dust disposal; materials in fine particle form may be explosive. Do not throw sanding dust on an open fire. Combustion from mixtures of varnishes, lacquers, polyurethane, oil or water with dust particles can occur if there is a static discharge, spark introduced in the box, or excessive heat.



ATTACHING TO A VACUUM CLEANER

⚠️ WARNING: The tool must be turned off before connecting to a vacuum hose.

Users can directly attach the vacuum hose to the dust extraction port

- 1) Remove the dust box from the sander.
- 2) To insert, slide the vacuum hose into the dust extraction port.

USING THE SANDER

- 1) Secure the work to prevent it from moving under the sander.
- 2) Hold the sander in front and away from you, keeping it clear of the workpiece.
- 3) Switch on the sander and let the motor build to its maximum speed before contacting the workpiece..
- 4) Gradually lower the sander on the work with a slight forward movement. Move it slowly using forward and backward strokes.
- 5) Always remove the sander from the workpiece before turning the sander off.

TOOL TIPS

If the surface is rough, begin with coarser grits and then complete the surfacing with medium and fine abrasives. To avoid uneven results, do not skip more than one grit size when going from coarser to finer grits, and do not sand in one area for too long.

NEVER FORCE THE SANDER. The weight of the sander supplies adequate pressure so let the sandpaper and the sander do the work. Applying additional pressure only slows the motor, rapidly wears the sandpaper and greatly reduces the sander speed. Excessive pressure will overload the motor causing possible damage from motor overheating and can result in inferior work.


Any finish or resin on wood may soften from frictional heat. This will cause the material to rapidly clog the sandpaper, rendering it useless. A heat gun will work much better to remove paint before sanding. Do not allow sanding on one spot too long, as the sander's rapid action may remove too much material, particularly when using only one corner of the pad, making the surface uneven.

SELECTION OF THE SANDING SHEET

Grain size P	Application
P 60	For pre-sanding rough wood surfaces
P 80 or P 120	For plain sanding
P 240	For fine sanding of primed and painted surfaces

5. REPLACEMENT OF PARTS AND MAINTENANCE

1) REPLACEMENT PARTS /ACCESSORIES

 **WARNING!** Only use accessories specified in the operating manual. Using the accessories other than those specific in the operating manual may cause a risk of injury. Only get the accessories from the Service Centre.

2) MAINTENANCE

 **WARNING! RISK OF INJURY!**

- Pull the mains plug before any adjustments, maintenance or repair.
- Repair and servicing work not described in this manual should always be carried by the Service Centre. Use only the original parts.
- The following cleaning and servicing should be done regularly. This will ensure a long and reliable service life.
- Do not spray the appliance with water and do not immerse it in water. **Electric Shock** hazard.
- Keep clean the ventilation slots, motor housing and handles of the appliance. Use a damp cloth or a brush. Do not use cleaning agents or solvents. You may otherwise irreparable damage the appliance.

3) STORAGE

- Switch off and unplug the appliance before storage.
- Allow the sander to cool down.
- Store the appliance in a dry and secure place well out of reach of children.
- Empty the dust collection box before storing the appliance.

4) TRANSPORT

Before transporting, observe the followings:

- Switch off and unplug the appliance.
- Allow the product to cool down.
- Put the appliance and accessories into the case.
