DESCRIPTION OF THE SYMBOLS

The use of symbols in this manual is intended to draw your attention to possible risks. The safety symbols and the explanations that accompany them must be perfectly understood. The warnings in themselves do not remove the risks and cannot replace correct actions for preventing accidents.

SAFETY INSTRUCTIONS

WARNING! Read all safety warnings and instructions.

Failing to follow the warnings and instructions can result in an electric shock, a fire and/or a serious injury.

Save all warnings and instructions for future reference. *The term "power tool" in the warnings refers to your mains-operated (corded) power tool or battery-operated (cordless) power tool.*

1) Work area safety

a) Keep work area clean and well lit. Cluttered or dark areas invite accidents.

b) Do not operate power tools in explosive atmospheres, such as in the presence of flammable liquids, gases or dust. *Power tools create sparks which may ignite the dust or fumes.*

c) Keep children and bystanders away while operating a power tool. *Distractions can cause you to lose control.*

2) Electrical safety

a) Power tool plugs must match the outlet. Never modify the plug in any way. Do not use any adapter plugs with earthed (grounded) power tools. Unmodified plugs and matching outlets will reduce risk of electric shock.

b) Avoid body contact with earthed or grounded surfaces, such as pipes, radiators, ranges and refrigerators. There is an increased risk of electric shock if your body is earthed or grounded.

c) **Do not expose power tools to rain or wet conditions.** *Water entering a power tool will increase the risk of electric shock.*

d) Do not abuse the cord. Never use the cord for carrying, pulling or unplugging the power tool. Keep cord away from heat, oil, sharp edges or moving parts. *Damaged or entangled cords increase the risk of electric shock.*

e) When operating a power tool outdoors, use an extension cord suitable for outdoor use. Use of a cord suitable for outdoor use reduces the risk of electric shock.

f) If operating a power tool in a damp location is unavoidable, use a residual current device (RCD) protected supply. Use of an RCD reduces the risk of electric shock.

NOTE the term "residual current device (RCD)" may be replaced by the term "ground fault circuit interrupter (GFCI)" or "earth leakage circuit breaker (ELCB)".

3) Personal safety

a) Stay alert, watch what you are doing and use common sense when operating a power tool. Do not use a power tool while you are tired or under the influence of drugs, alcohol or medication. *A* moment of inattention while operating power tools may result in serious personal injury.

b) Use personal protective equipment. Always wear eye protection. Protective equipment such as dust mask, non-skid safety shoes, hard hat, or hearing protection used for appropriate conditions will reduce personal injuries.

c) Prevent unintentional starting. Ensure the switch is in the off-position connecting to power source and/or battery pack, picking up or carrying the tool. *Carrying power tools with your finger on the switch or energizing power tools that have the switch on invites accidents.*

d) **Remove any adjusting key or wrench before turning the power tool on.** A wrench or a key left attached to a rotating part of the power tool may result in personal injury.

e) Do not overreach. Keep proper footing and balance at all times. This enables better control of the

power tool in unexpected situations.

f) Dress properly. Do not wear loose clothing or jewellery. Keep your hair, clothing and gloves away from moving parts. Loose clothes, jewellery or long hair can be caught in moving parts.

g) If devices are provided for the connection of dust extraction and collection facilities, ensure these are connected and properly used. Use of dust collection can reduce dust-related hazards.

h) Do not let familiarity gained from frequent use of tools allow you to become complacent and ignore tool safety principles. *A careless action can cause severe injury within a fraction of asecond.*4) Power tool use and care

a) **Do not force the power tool. Use the correct power tool for your application.** *The correct power tool will do the job better and safer at the rate for which it was designed.*

b) **Do not use the power tool if the switch does not turn it on and off.** *Any power tool that cannot be controlled with the switch is dangerous and must be repaired.*

c) Disconnect the plug from the power source and/or the battery pack from the power tool before making any adjustments, changing accessories, or storing power tools. Such preventive safety measures reduce the risk of starting the power tool accidentally.

d) Store idle power tools out of the reach of children and do not allow persons unfamiliar with the power tool or these instructions to operate the power tool. Power tools are dangerous in the hands of untrained users.

e) Maintain power tools. Check for misalignment or binding of moving parts, breakage of parts and any other condition that may affect the power tool's operation. If damaged, have the power tool repaired before use. *Many accidents are caused by poorly maintained power tools*.

f) **Keep cutting tools sharp and clean.** Properly maintained cutting tools with sharp cutting edges are less likely to bind and are easier to control.

g) Use the power tool, accessories and tool bits etc. in accordance with these instructions, taking into account the working conditions and the work to be performed. Use of the power tool for operations different from those intended could result in a hazardous situation.

h) Keep handles and grasping surfaces dry, clean and free from oil and grease. Slippery handles and grasping surfaces do not allow for safe handling and control of the tool in unexpected situations.

5) Service

a) Have your power tool serviced by a qualified repair person using only identical replacement **parts.** *This will ensure that the safety of the power tool is maintained.*

Planer safety warnings

- Wait for the cutter to stop before setting the tool down. An exposed rotating cutter may engage the surface leading to possible loss of control and serious injury. NOTE The above warning applies only to planers without an automatic closing guard.

- Hold the power tool by insulated gripping surfaces only, because the cutter may contact its own cord. Cutting a "live" wire may make exposed metal parts of the power tool "live" and could give the operator an electric shock.

-Use clamps or another practical way to secure and support the workpiece to a stable platform. Holding the work by your hand or against the body leaves it unstable and may lead to loss of control.



Some dust created by power sanding, sawing, grinding, drilling, and other construction activities contains chemicals known to cause cancer, birth defects or other reproductive harm. Some examples of these chemicals are:

- lead from lead-based paints,

- crystalline silica from bricks and cement and other masonry products, and


The emission of vibration during actual use of the machine tool may differ from the total declared value depending on how the tool is used.

OPERATION

Before use

Before making assembly, changing and adjustment for any accessory, disconnect the tool from the mains supply to avoid any unintentional starting.

Please always check the mains supply voltage before use! It must correspond with the rating label on the appliance.

Remove any packing material and loose parts from unit.

Check the accessories before use. It should be fit with the machine and your purpose.

Never use any damaged or deformed blade in planer.

Check the blade before use. It must be fixed correctly.

Adjust the cutting depth

For optimal quality of cutting, the please select smaller cutting depth and finish working in 2 or 3 times.

To adjust the cutting depth (0-2mm), please follow below steps:

1. Rotate the cutting depth adjusting knob clockwise for a deeper cut and anti-clockwise for shallower cut.

2. The numbers on the ring under the depth adjustment knob indicate the depth of cut. For example when '2' is next to the pointer on the front of the planer, the depth of cut is approximately 2mm.

3. If it is necessary to accurately determine the depth of cut, plane a scrap piece of wood, measure the difference in thickness and adjust the setting if necessary.

CAUTION!

Always check the nuts and bolts which fix the blades before working. Loosed blade may cause serious injure.

On/Off switch

Use the On/Off switch and interlock switch to start the machine and keep holding it for continuous operation.

The machine can only be started by depressing the interlock switch first, preventing any unintentional operation.

To switch the machine off, release the On/Off switch.

CAUTION!

Always hold the machine by both hands.

Never start the planer with the blade in contact with the workpiece. Start cutting only after the motor reached its full speed.

Always carry out a test run before starting work and after every tool change! Always ensure that the tools are in good condition, correctly mounted and able to turn freely. The trial run should be at last 30 sec.

Damaged or deformed blade must be replaced immediately.

Chamfering edges

For chamfering edges use the V-grooves in the front base.

Set cutting depth adjusting knob in "0" position and then run the planer along the corner edge.

Caution!

Always test out first on a piece of scrap material for chamfering edges.

Mounting and replace blades

CAUTION!

Always switched off the tool and unplug it from the power supply before installing.

The planer is fitted with reversible blades. Blades can be reversed when blunt. If both sides of the blades have been used, it should be replaced immediately.

NOTE: These blades can not be re-sharpened.


To replace the blades, please follow below steps:

- 1. Using the supplied spanner to loose the three clamping screws.
- 2. Push blade out of the slot in the blade barrel with one piece of wood.
- 3. Turn over the planer blade or replace it if required.

4. Slide the good blade into the the blade barrel and make sure both knife ends protruded equally.

5. Tighten the clamping screws carefully, ensuring they are tightened evenly.

NOTE: The ridge along the blade should be on the blade face on the opposite side to the clamping screws.



NOTE: Always change the blades at the same time, otherwise imbalance can cause vibration and reduce the blades and tool life.

CAUTION!

Do not attempt to adjust the blade with cutter block screws, which are pre-set at manufacturing.

Drive belt replacement

The drive belt is expendable. It is keeping abrasion during use. The drive belt should be changed regularly.

CAUTION!

Replacing the drive belt should be done by authorized service only. The machine should be used only with drive belt!

To replace the drive belt, please fellow below steps:

1. Take away the drive belt cover by remove the fixing screws.

2. Remove the damaged belt and use a soft brush to clean the pulleys and the surrounding area.

3. With the three continuous "v" profiles on the inside, place the new belt over the bottom pulley. Half fit the other end of the belt on the top pulley then roll the belt in place whilst turning the pulley.

4. Check that the belt runs evenly by manually turning the belt and then re-assembly the drive belt cover.

5. Carry out a test run before starting work to ensure that the tools are in good condition, correctly mounted and able to turn freely. The trial run should be at last 60 sec

Dust suction

The dust will be collected by the dust exhaust tube to the vacuum cleaner during use. To assembly the vacuum cleaner, please follow below steps:

- Remove the accessories on soft tube of vacuum cleaner.
- Connect the soft tube to the dust exhaust tube directly.

APPLICATION ADVICE

CAUTION!

Always switched off the tool and unplug it from the power supply before installing.

Please always properly secure the workpiece before working.

Incline the workpiece slightly away from user, it may make planning easily.

Ensure that the openings provided for ventilation of the motor are clear.

Practice first on a scrap piece of material to gauge the correct feed rate and the cut dimensions.

CAUTION!

Never cut the unsecured workpiece!

The rate of planning and the depth of cut determine the quality of the finish. For rough cutting, the user can increase the depth of cutting. However to achieve a good finish you will need to reduce the depth of cutting and advance the tool more slowly.

The proper feed rate will depend on the type of material being cut and the quality requirement of finish. Normally, the harder material need slower speed.



Don't apply big pressure to the machine.

Best cutting results can be obtained by only a slight pressure on the tool; Forcing and excessive pressure will damage the blade and cause serious personal injury.

Moving the machine too fast may cause a poor quality of cuting and can damage the blades or the motor. Moving the machine too slowly may burn or mar the workpiece.

MAINTENANCE

Keep the ventilation openings clear and clean the product regularly.

If something unusual occurs during use, switch off the supply and disconnect the plug. Inspect and repair the tool before using it again. The repairs must be carried out by a qualified technician. **Repair of the tool must only be carried out by a qualified repair technician.** Repair or maintenance by unqualified personnel can lead to a risk of injury.

Use only identical spare parts for repairing a tool. Follow the instructions in the maintenance section of this user manual.

Caution!

If the replacement of the supply cord is necessary, this has to be done by the manufacturer or his agent in order to avoid a safety hazard.

Care and cleaning

Clean the housing only with a damp cloth-do not uses any solvents! Dry thoroughly afterwards.

STORING

Store the machine, operating instructions and where necessary the accessories in the original packaging. In this way you will always have all the information and parts ready to hand.

Pack the device well or use the original packaging in order to avoid transit damage. Always keep the machine in dry place.

DISPOSAL



Do not dispose of power tools into household waste! According the European Guideline 2012/19/EU for Waste Electrical and Electronic Equipment and its implementation into national right, power tools that are no longer usable must be collected separately and disposed of in an environmentally correct manner.
