1. INTENDED USE

This device is only intended as an electric tiller for aerating lawns and grassy areas in private domestic and hobby gardens.

It is not designed for use in public areas, parks, sports

areas, and in agriculture and forestry.

Using the application for any other purpose

considered incorrect and unapproved.

The manufacturer is not liable for any damage or injury resulting from such use. The user is entirely responsible for any associated risks.

2. SAFETY WARNINGS

Read the operating instructions and act accordingly. Keep it for general use.

Comply with the safety information and the warning on

the device.

Always use this device according to the instructions in this manual.

1) TRAINING

a) Read the instructions carefully. Be familiar with the

controls and the proper use of the equipment.
b) Never allow children or people unfamiliar with these instructions to use the machine. Local regulations can restrict the age of the operator.

c) Never work while people, especially children, or pets

are nearby.

d) Keep in mind that the operator or user is responsible for accidents or hazards occurring to other people or their property.

2) PREPARATION

a) While working, always wear substantial footwear and long trousers. Do not operate the equipment when barefoot or wearing open sandals.

b) Thoroughly inspect the area where the equipment is to be used and remove all objects which can be

thrown up by the machine.

c) Before using, always visually inspect to see that the tools are not worn out or damaged. Replace worn out or damaged elements and bolts in sets to preserve balance.

3) OPERATION

- a) Do not operate the engine in a confined space where dangerous carbon monoxide fumes can collect.
- b) Work only in daylight or in good artificial light.
- c) Always be sure of your footing on slopes.

d) Walk, never run with the machine.

e) Work across the slopes, never up and down.

f) Exercise extreme caution when changing direction on slopes.

g) Do not work on excessively steep slopes.

- h)Use extreme caution when reversing or pulling the machine towards you.
- i) Do not change the engine governor settings or over speed the engine.
- j) Start the engine carefully according to manufacturer instructions and with feet well away from the tool.
- k) Do not put your hands or feet near or under rotating parts.
- I) Never pick up or carry a machine while the engine is running.
- m) Stop the engine when you leave the machine.

4) MAINTENANCE AND STOCKAGE

- a) Keep all nuts, bolts and screws tight to ensure the equipment is in safe working condition.
- b) Allow the engine to cool before storing enclosure.
- c) To reduce the fire hazard, keep the engine free of vegetative material and excessive grease.

d) Replace worn or damaged parts for safety.

5) BEFORE OPERATION

- a) The machine should always be used according to the manufacturer's instructions in the instruction manual.
- b) The machine must be stopped when carrying out maintenance and cleaning operations, when changing tools or when transported by means other than under its own power.

c) The machine must be used by appropriately trained

people.

d) The device must be assembled correctly before use.

- e) The device should be checked carefully before use. You should only work with an device that is in good condition. If you notice any defect on the machine that may cause danger to the operator, do not operate the device until defects are rectified.
- f) Replace worn or damaged parts for safety. Use only original spare parts. Parts not produced manufacturer may cause poor fit and possible injury.

g) Before use, all foreign bodies must be removed from the lawn, also pay attention to foreign bodies during the operation.

h) Only work in daylight or sufficiently good artificial light.

i) Wear eye protection and face or dust mask if operating in dusty conditions.
j) Dress properly. Wear the following clothing while

using the application:

- Use of rubber gloves and substantial footwear is recommended.
- Wear protective hair covering to contain long hair.

> Avoid wearing loose clothing or jewelry that could

get caught in the rotating tines.

Carry always resistant footwear and long trousers. Do not use the machine when they are bare feet or in sandals.

6) PROPER USE

The user is responsible for third parties while working with the device.

- a) People not acquainted with the operating instructions, children, juveniles who have not yet reached the minimum age for using this device, and people under the influence of alcohol, drugs or medication are not allowed to use the device.
- b) Children and adolescents under the age of 16 and persons unfamiliar with the instruction manual are not allowed to use the device.
- c) People whose physical, sensory or intellectual abilities are or who do not have the necessary experience and / or knowledge are not allowed to use the machine unless they are supervised or instructed about the handling of the machine by a person in charge of safety.
- d) Supervise children to make sure they do not play with the machine.
- e) Only use the device for its designed purposes.
- f) Keep children and pets away. All onlookers should be kept a safe distance away from the device when it is in use.
- g) Make sure that all the protective devices are fitted and in good condition.
- h) Do not operate the application near underground electric cables, telephone lines, pipes or hoses.i) Before connection the plug, make sure that the socket
- i) Before connection the plug, make sure that the socket ratings are correct and correspond to those indicated on the rating label on the device.
- j) The use of the device is only permitted if the safety distance provided by the guide bar is complied with.
- k) Do not operate the application on a slope that is too steep for safe operation.
- I) When on slopes, slow down and make sure you have good footing.
- m) Before starting the application, make sure tines are not touching foreign objects and must be completely free to move.
- n) Grip guide bar firmly with both hands. Never operate the application with one hand.

- o) Be aware that the application may unexpectedly bounce upward or jump forward if the tines should strike extremely hard, packed soil, frozen ground, or buried obstacles such as large stones, roots or stumps.
- p) Do not put hands, feet or any body part or clothing in the vicinity of rotating tines. Caution! Risk of injury!
 q) Only guide the device at walking pace. Do not overreach. Always maintain proper footing and balance.
- r) Be aware of extension cord while operation. Be careful not to trip over cord. Always guide the cord away from tines.
- s) If the device strikes a foreign body, examine the application for signs of damage and carry out any necessary repairs before restarting and continuing to work.
- t) If the device should start to vibrate abnormally, switch off the motor and check for the cause immediately. Vibration is generally a warning of trouble.
- u) Holding the guide bar and lift the application to move it from one place to another.
- v) Always switch off the device, disconnect the plug and wait until the application stops before carrying out maintenance or cleaning work. Caution! Tines do not stop immediately after switching off.
- Use caution when cleaning or performing maintenance on the device. DANGER! Watch your w) Use fingers! Wear gloves!
- x) It is forbidden to move or modify any of the electrical and mechanical safety devices.
- y) The machine must be stopped when carrying out maintenance and cleaning operations, when changing tools or when transported by means other than under its own power. If the supply cord is damaged, it must be replaced by a special cord or assembly available from the manufacturer or its service agent.

7) ELECTRICAL SAFETY

a) The mains voltage must correspond to the one marked on the technical data plate (230V~50Hz). Do not use other sources of power.

b) The use of a safety circuit-breaker is recommended for the power supply line for an intervention range of 10 to 30 rated mA. Consult a reliable electrician.

c) Never pass the device over the extension cable that the application is working, as this could cut the cable. Mark sure you always know where the cable is. d) Use the special cable holder for the connection of the

extension cable.

e) Never use the device when it is raining. Try to prevent it from getting wet or being exposed to humidity. Do not leave it outside overnight. Do not cut damp or wet

grass.

f) The power supply cable should be checked regularly and before using it each time, make sure the cable is not damaged or old out. If the cable is not in good condition, do not use the device; take it to an authorized service center instead.

g)Only use an extension cable that is suitable for outdoor work. Keep it away from the cutting area, from damp, wet or oily surfaces or with sharp edges and away from heat and fuels.

h) The mobile socket of the extension cable should be splash proof in compliance with DIN 57282 and VDE 0282 regulations; the cross-section of the wire (max. length 75 m) should be at least 1.5 mm². Use H07RN-F harmonized cable.

i) If the supply cord is damaged, it must be replaced by a special cord or assembly available from the manufacturer or its service agent.
j) CAUTION: To avoid a hazard due to inadvertent

resetting of the thermal cut-out, this appliance must not be supplied through an external switching device,

such as a timer, or connected to a circuit that is regularly switched on and off by the utility.

8) DOUBLE INSULATION

The application has double insulation. This means that all external metal parts are insulated from the

electrical supply.

This is achieved by introducing an insulation layer between electrical and mechanical parts. The double insulation guarantees you the greatest possible safety.




- The vibration and noise emissions during actual use of the power tool can differ from the declared values depending on the ways in which the tool is used especially what kind of workpiece is processed.

- Wear hearing protection.


4. ASSEMBLY

IMPORTANT! You must fully assemble the appliance before using it for the first time!












- Attach the lower bars (04) as shown in picture 2 and tighten the screws (05). (fig. 2)
- Connect the bar (03) and the handle (01) to the lower bars (04) using the wing nut (09) and lock screw (08) (fig. 3,4)
- Laying the power cord
 - Mount the cable and the cable guide (10) on the lower right bar (04) (fig. 5,6).
- Blade roller installing.



- Push the blade roller (07) on the drive shaft (15) of the machine. The blade roller (07) can be mounted on the left or right side. Be sure that the holes of the blade roller (07) and the drive shaft (15) are aligned. Now push through the Screw M8 (14) and fix it with the nut M8 (13). Lock the nut M8 (13) and tighten with hands. (fig. 7)
- For uninstall: Proceed in reverse order.


Install the wheel






- Remove the pre-assembled split pin (20) and the washer (18). Place the wheel (16) on the wheel holder (19). Secure it with the washer (18) and the split pin (20). Then mount the wheel cap (17). (fig. 8,9)
- Assembly is identical on both sides.

Transport and storage






- Always pull out the power cord before transporting! Pull the lock pin (21). You can now move the wheels (16) to the lower position. Make sure that the lock pin (21) engages again in the lower position. (fig. 11)
- Attention! The wheels must be fixed in the upper position during operation! (fig. 10)
- For storage or transport in a limited space, proceed as follows: Open the wing nuts (09) until you can fold the handles forward. Attention! Danger of crushing your fingers.
- Now you can transport your machine with the transport handle (03).

So, you can storage the machine.

5. OPERATION


5.1 START AND STOP



- To prevent an accidental start-up of the implement, the throttle handle (01) is equipped with a safety release switch (11) which must be pressed before the On/Off switch (12) can be pressed. If the On/Of switch (12) is released, the equipment switches off.
- Repeat this process several times so that you are sure that the machine functions properly.
 Before you perform any repair or maintenance work on the machine, ensure that the cutting unit is not rotating and that the power supply is disconnected.
- The safety distance between housing and user giver by the handle (01) must always be observed. Be especially careful when digging and changing direction or slopes and inclines. Maintain a solid footing and wear sturdy, non-slip footwear and long trousers. Always dig along the incline (not up and down).
- For safety reasons, the Electric Tiller may not be

used to dig up inclines whose gradient exceeds

15 degrees. Use special caution when backing up and pulling the implement (tripping hazard)!



Tips

- Move the application to the work area prior to starting the motor.
- Hold the application firmly while switch on.
- ➤ The tines will pull the tiller forward during operation, press the guide bar to lower the tines slowly.
- > By pulling tiller back towards yourself, the tines will dig deeper and more aggressively.

- For breaking sod or deep tilling, allow the tines to pull the tiller forward to the end of your arm's reach, then firmly pull the tiller back towards you. By repeatedly allowing the tiller to move forward and then pulling back to you, the tiller will be most effective.
- If the tiller digs deep enough to stay in one spot, gently rock the tiller side to side to start the tiller moving forward again.
- For preparing seed bed, we recommend using one of the tilling patterns shown in Fig. 14.
- ➤ Tilling Pattern A Make two passes over area to be tilled, the second at a right angle to the first.
- Tilling Pattern B Make two passes over area to be tilled, the second overlapping the first.
- ➤ To prevent tripping take particular care when moving backwards and when pulling the tiller.
- Always let the tines rotates at top speed; do not work in such a way as to overload the appliance.
- Never pass the tiller over the extension cord; make sure it is always in a safe position behind your back.
- ➤ When working on inclines always stand diagonally to the incline in a sturdy, safe stance. Do not work on extremely steep slopes.

6. MAINTENANCE AND STORAGE

The insulation on electrical connection cables is often damaged. This may have the following causes:

- Passage points, where connection cables are passed through windows or doors.
- Kinks where the connection cable has been improperly fastened or routed.
- Places where the connection cables have been cut due to being driven over.
- Insulation damage due to being ripped out of the wall outlet.
- Cracks due to the insulation ageing. Such damaged electrical connection cables must not be used and are life-threatening due to the insulation damage. Check the electrical connection cables for damage regularly. Make sure that the connection cable does not hang on the power network during the inspection.

Maintenance

- A worn out or damaged cutting unit should be replaced by an expert.
- Take care that all fastening elements (screws, nuts, etc.) are firmly tightened, so that you can
 work safely with the Electric Tiller.
- Store the Electric Tiller in a dry place.
- For longer life, all screw-fastened parts, such as wheels and axles should be cleaned and subsequently oiled.
- Regular servicing of the implement not only secures longer endurance and performance, it
- also contributes to an accurate and simple dig up of your bed.
- At the end of the season, carry out a general check of the Electric Tiller, and remove all residue collected. Before the start of every season, it is absolutely necessary to check the state of the machine. Contact our Customer Service if repair work is necessary.

CLEANING

- Keep all safety devices, air vents and the motor housing free of dirt and dust as far as possible.
 Wipe the equipment with a clean cloth or blow it with compressed air at low pressure.
- We recommend that you clean the device immediately each time you have finished using it.
- Clean the equipment regularly with a moist cloth and some soft soap. Do not use cleaning
 agents or solvents; these could attack the plastic parts of the equipment. Ensure that no water

can seep into the device. The ingress of water into an electric tool increases the risk of an electric shock.

STORAGE

Store the Tiller in a dry, clean area out of reach of children.

During extended periods of storage, ensure that the tiller/ cultivator is protected against corrosion and frost.

At the end of the season, or if the tiller is not being used for longer than a month, wipe over all metal surfaces with an oil impregnated cloth to protect them from corrosion or spray with a fine coat of oil. Fold the guide bar down, and store the tiller in a suitable place.
