## 1. INTENDED USE

This device is only intended as an electric tiller for aerating lawns and grassy areas in private domestic and hobby gardens.

It is not designed for use in public areas, parks, sports areas, and in agriculture and forestry.

Using the application for any other purpose is considered incorrect and unapproved.

The manufacturer is not liable for any damage or injury resulting from such use. The user is entirely responsible for any associated risks.

## 2. SAFETY WARNINGS

Read the operating instructions and act accordingly.

Keep it for general use.

Comply with the safety information and the warning on the device.

Always use this device according to the instructions in this manual.

### 1) TRAINING

- a) Read the instructions carefully. Be familiar with the controls and the proper use of the equipment.
- b) Never allow children or people unfamiliar with these instructions to use the machine. Local regulations can restrict the age of the operator.
- c) Never work while people, especially children, or pets are nearby.
- d) Keep in mind that the operator or user is responsible for accidents or hazards occurring to other people or their property.

### 2) PREPARATION

- a) While working, always wear substantial footwear and long trousers. Do not operate the equipment when barefoot or wearing open sandals.

- b) Thoroughly inspect the area where the equipment is to be used and remove all objects which can be thrown up by the machine.
- c) Before using, always visually inspect to see that the tools are not worn out or damaged. Replace worn out or damaged elements and bolts in sets to preserve balance.

### **3) OPERATION**

- a) Do not operate the engine in a confined space where dangerous carbon monoxide fumes can collect.
- b) Work only in daylight or in good artificial light.
- c) Always be sure of your footing on slopes.
- d) Walk, never run with the machine.
- e) Work across the slopes, never up and down.
- f) Exercise extreme caution when changing direction on slopes.
- g) Do not work on excessively steep slopes.
- h) Use extreme caution when reversing or pulling the machine towards you.
- i) Do not change the engine governor settings or over speed the engine.
- j) Start the engine carefully according to manufacturer instructions and with feet well away from the tool.
- k) Do not put your hands or feet near or under rotating parts.
- l) Never pick up or carry a machine while the engine is running.
- m) Stop the engine when you leave the machine.

### **4) MAINTENANCE AND STOCKAGE**

- a) Keep all nuts, bolts and screws tight to ensure the equipment is in safe working condition.
- b) Allow the engine to cool before storing in any enclosure.
- c) To reduce the fire hazard, keep the engine free of vegetative material and excessive grease.
- d) Replace worn or damaged parts for safety.

## 5) BEFORE OPERATION

- a) The machine should always be used according to the manufacturer's instructions in the instruction manual.
- b) The machine must be stopped when carrying out maintenance and cleaning operations, when changing tools or when transported by means other than under its own power.
- c) The machine must be used by appropriately trained people.
- d) The device must be assembled correctly before use.
- e) The device should be checked carefully before use. You should only work with an device that is in good condition. If you notice any defect on the machine that may cause danger to the operator, do not operate the device until defects are rectified.
- f) Replace worn or damaged parts for safety. Use only original spare parts. Parts not produced by manufacturer may cause poor fit and possible injury.
- g) Before use, all foreign bodies must be removed from the lawn, also pay attention to foreign bodies during the operation.
- h) Only work in daylight or sufficiently good artificial light.
- i) Wear eye protection and face or dust mask if operating in dusty conditions.
- j) Dress properly. Wear the following clothing while using the application:
  - Use of rubber gloves and substantial footwear is recommended.
  - Wear protective hair covering to contain long hair.
  - Avoid wearing loose clothing or jewelry that could get caught in the rotating tines.
  - Carry always resistant footwear and long trousers. Do not use the machine when they are bare feet or in sandals.

## 6) PROPER USE

The user is responsible for third parties while working with the device.

- a) People not acquainted with the operating instructions, children, juveniles who have not yet reached the minimum age for using this device, and people under the influence of alcohol, drugs or medication are not allowed to use the device.
- b) Children and adolescents under the age of 16 and persons unfamiliar with the instruction manual are not allowed to use the device.
- c) People whose physical, sensory or intellectual abilities are or who do not have the necessary experience and / or knowledge are not allowed to use the machine unless they are supervised or instructed about the handling of the machine by a person in charge of safety.
- d) Supervise children to make sure they do not play with the machine.
- e) Only use the device for its designed purposes.
- f) Keep children and pets away. All onlookers should be kept a safe distance away from the device when it is in use.
- g) Make sure that all the protective devices are fitted and in good condition.
- h) Do not operate the application near underground electric cables, telephone lines, pipes or hoses.
- i) Before connection the plug, make sure that the socket ratings are correct and correspond to those indicated on the rating label on the device.
- j) The use of the device is only permitted if the safety distance provided by the guide bar is complied with.
- k) Do not operate the application on a slope that is too steep for safe operation.
- l) When on slopes, slow down and make sure you have good footing.
- m) Before starting the application, make sure tines are not touching foreign objects and must be completely free to move.
- n) Grip guide bar firmly with both hands. Never operate the application with one hand.

- o) Be aware that the application may unexpectedly bounce upward or jump forward if the tines should strike extremely hard, packed soil, frozen ground, or buried obstacles such as large stones, roots or stumps.
- p) Do not put hands, feet or any body part or clothing in the vicinity of rotating tines. Caution! Risk of injury!
- q) Only guide the device at walking pace. Do not over reach. Maintain proper footing and balance at all times.
- r) Be aware of extension cord while operation. Be careful not to trip over cord. Always guide the cord away from tines at all times.
- s) If the device strikes a foreign body, examine the application for signs of damage and carry out any necessary repairs before restarting and continuing to work.
- t) If the device should start to vibrate abnormally, switch off the motor and check for the cause immediately. Vibration is generally a warning of trouble.
- u) Holding the guide bar and lift the application to move it from one place to another.
- v) Always switch off the device, disconnect the plug and wait until the application stops before carrying out maintenance or cleaning work. Caution! Tines do not stop immediately after switching off.
- w) Use caution when cleaning or performing maintenance on the device. DANGER! Watch your fingers! Wear gloves!
- x) It is forbidden to move or modify any of the electrical and mechanical safety devices.
- y) The machine must be stopped when carrying out maintenance and cleaning operations, when changing tools or when transported by means other than under its own power. If the supply cord is damaged, it must be replaced by a special cord or assembly available from the manufacturer or its service agent.

## 7) ELECTRICAL SAFETY

- a) The mains voltage must correspond to the one marked on the technical data plate (230V~50Hz). Do not use other sources of power.
- b) The use of a safety circuit-breaker is recommended for the power supply line for an intervention range of 10 to 30 rated mA. Consult a reliable electrician.
- c) Never pass the device over the extension cable that the application is working, as this could cut the cable. Mark sure you always know where the cable is.
- d) Use the special cable holder for the connection of the extension cable.
- e) Never use the device when it is raining. Try to prevent it from getting wet or being exposed to humidity. Do not leave it outside overnight. Do not cut damp or wet grass.
- f) The power supply cable should be checked regularly and before using it each time, make sure the cable is not damaged or old out. If the cable is not in good condition, do not use the device; take it to an authorized service center instead.
- g) Only use an extension cable that is suitable for outdoor work. Keep it away from the cutting area, from damp, wet or oily surfaces or with sharp edges and away from heat and fuels.
- h) The mobile socket of the extension cable should be splash proof in compliance with DIN 57282 and VDE 0282 regulations; the cross-section of the wire (max. length 75 m) should be at least 1.5 mm<sup>2</sup> . Use H07RN-F harmonized cable.
- i) If the supply cord is damaged, it must be replaced by the manufacturer, its service agent or similarly qualified persons in order to avoid a hazard.
- j) CAUTION: In order to avoid a hazard due to inadvertent resetting of the thermal cut-out, this appliance must not be supplied through an external switching device, such as a timer, or connected to a










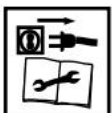
circuit that is regularly switched on and off by the utility.





## 8) DOUBLE INSULATION

The application has double insulation. This means that all external metal parts are insulated from the electrical supply.

This is achieved by introducing an insulation layer between electrical and mechanical parts. The double insulation guarantees you the greatest possible safety.

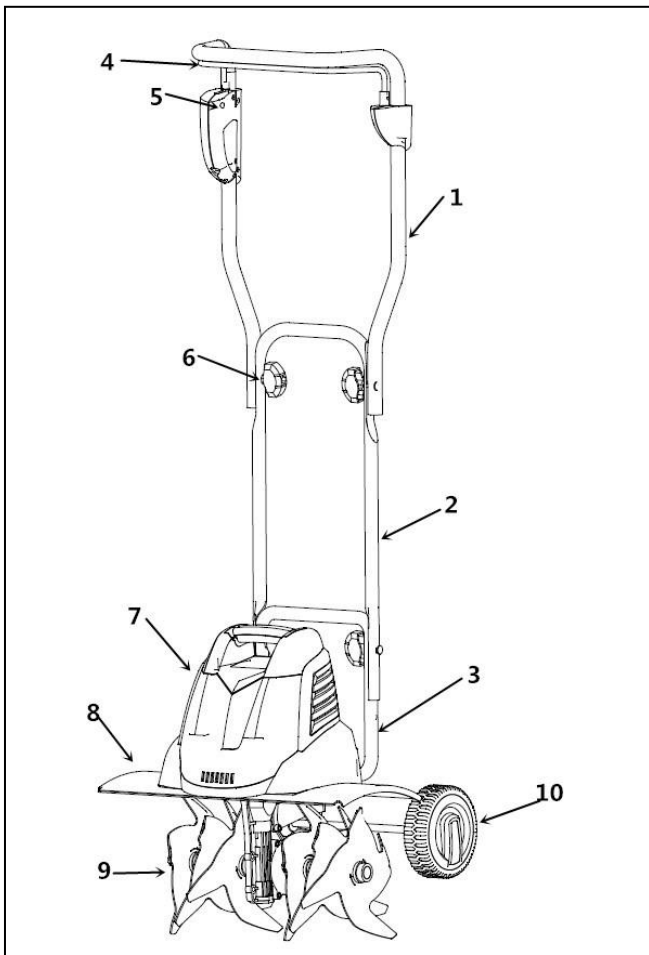

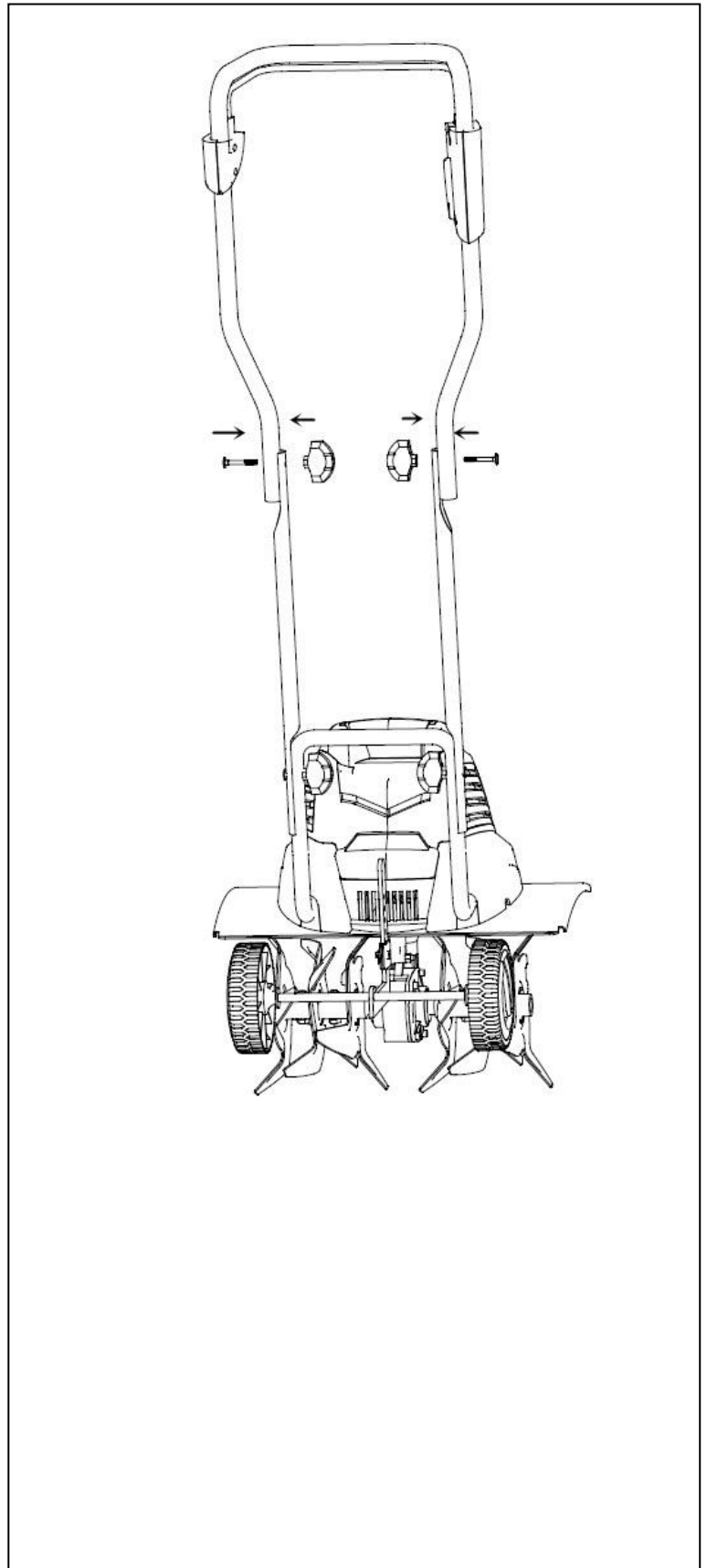
This product must be assembled correctly before use.

- 1) Open the package and remove the machine from package. Taking out the main part of the machine and accessories
- 2) Assembling the wheel
  - a) Put the wheel axle through the wheel bracket, and put the gasket through the wheel axle, then put the wheel through the wheel axle(Fig.1)
  - b) After fixed the wheel, and fixed the wheel gasket and pin(Fig.2&Fig.3)
  - c) Putting the wheel cover (Fig.4 & Fig.5)
  - d) Adjusting the height. Adjust and align the wheel setting hole to the bracket hole, then insert the bolt and secure it with the pin(Fig.6 & Fig.7 &Fig.8 &Fig.9)
- 3) Assembling the middle handle (Fig. 10)
- 4) Assembling the upper handle( Fig 11)

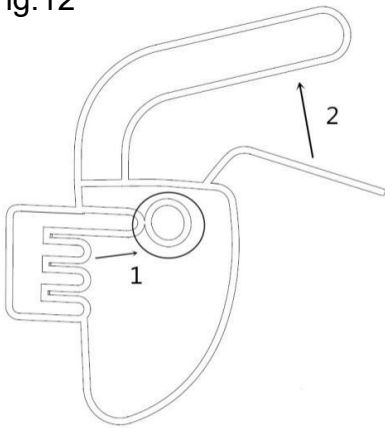

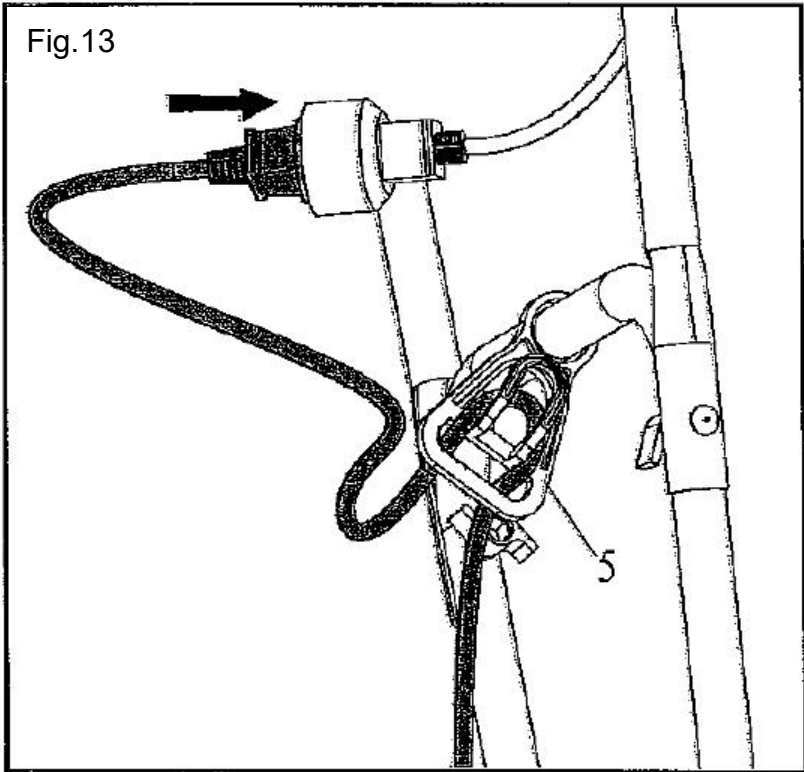
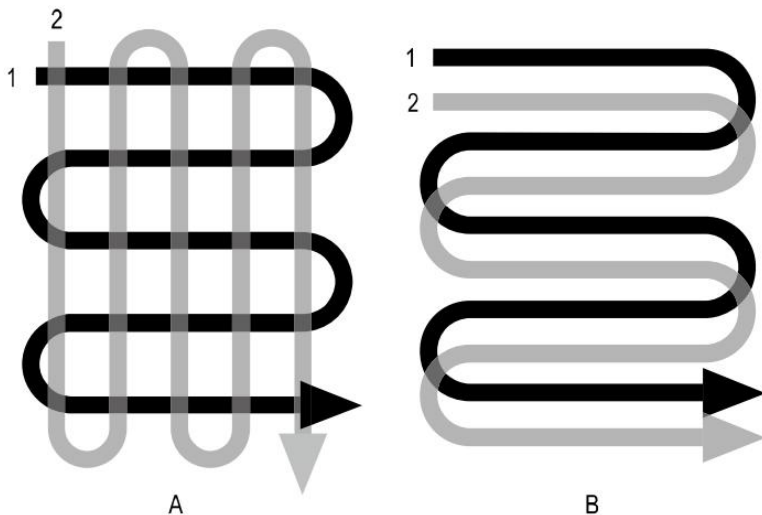

- 1) Press the safety lock button(1)
- 2) Lift the switch trigger (2) (See Fig.12)

**To start** the tiller press the safety lock button (1) on the safety switch and then pull the trigger lever (2) up and against the handle bar. The motor will start and the tines will begin to rotate.

**To stop** the tiller simply releases the lever.

Fig.13 : Secure the extension cord into the cord retainer (5). The loop of the extension cord must be long enough for the cord retainer to freely slide from one side to the other. Plug the extension cord into the power cord plug on the tiller.

For breaking sod or deep tilling, allow the tines to pull the tiller forward to the end of your arm's reach, then firmly pull it back toward yourself. You will achieve the best results by repeatedly allowing it to move forward and pulling it back.

By pulling the tiller back towards yourself, the tines will dig deeper and more aggressively. To prevent tripping, take extra precautions when moving backwards and when pulling the tiller back toward yourself.

If the tiller digs deep enough to stay in one spot, gently rock it side to side until it starts moving forward again.

Never pass the tiller over the extension cord. Make sure the cord is always in a safe position behind you.

When working on inclines always stand diagonally to the incline to retain a firm, safe footing. Do not work on extremely steep slopes.

Before use, remove any visible stones or other foreign bodies from the area.

**CAUTION:** Before moving the tiller from one area to another switch off the motor and wait for the tines to come to a complete stop. Be careful not to let the tines touch the ground while moving the tiller. The tines as well as the unit itself may be damaged even if the motor is switched off.

### **Clearing foreign objects:**

During operation a stone or root could become lodged in the tines, or tall grass **or** weeds may become wrapped around the tine shaft. To clear the tines or tine shaft release the trigger lever, wait for the tines to come to a complete stop and unplug the tiller. Dislodge or remove the foreign matter from the tines or tine shaft. To simplify removal of tall grass or weeds from the tine shaft, remove one or more of the tines. See the chapter: **Tines removal and installation.**

### **Tips**

- Move the application to the work area prior to starting the motor.
- Hold the application firmly while switch on.
- The tines will pull the tiller forward during operation, press the guide bar to lower the tines slowly.
- By pulling tiller back towards yourself, the tines will dig deeper and more aggressively.
- For breaking sod or deep tilling, allow the tines to pull the tiller forward to the end of your arm's reach, then firmly pull the tiller back towards you. By repeatedly allowing the tiller to move forward and then pulling back to you, the tiller will be most effective.
- If the tiller digs deep enough to stay in one spot, gently rock the tiller side to side to start the tiller moving forward again.
- For preparing seed bed, we recommend using one of the tilling patterns shown in Fig. 14.
- Tilling Pattern A – Make two passes over area to be tilled, the second at a right angle to the first.
- Tilling Pattern B – Make two passes over area to be tilled, the second overlapping the first.
- To prevent tripping take particular care when moving backwards and when pulling the tiller.
- Always let the tines rotate at top speed; do not work in such a way as to overload the appliance.
- Never pass the tiller over the extension cord; make sure it is always in a safe position behind your back.
- When working on inclines always stand diagonally to the incline in a sturdy, safe stance. Do not work on extremely steep slopes.



## 6. MAINTENANCE AND STORAGE

**Before carrying out maintenance operations, disconnect power supply.**

**CAUTION:** Always clean the tiller after each use. Failure to carry out proper cleaning can result in damage to the tiller or result in poor performance.

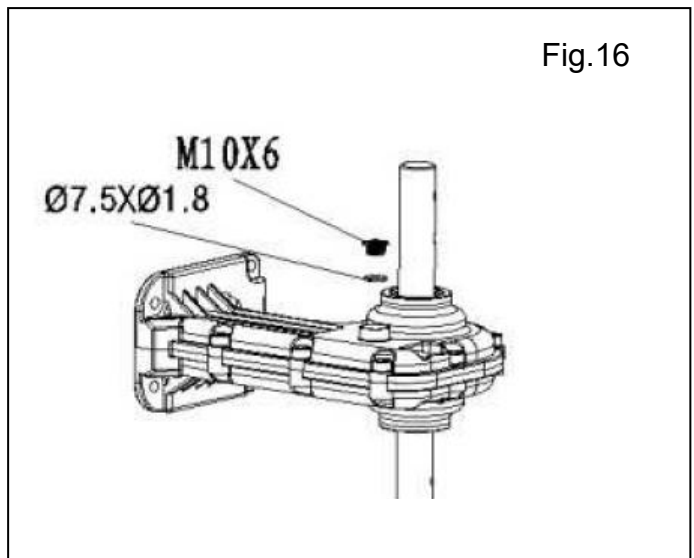
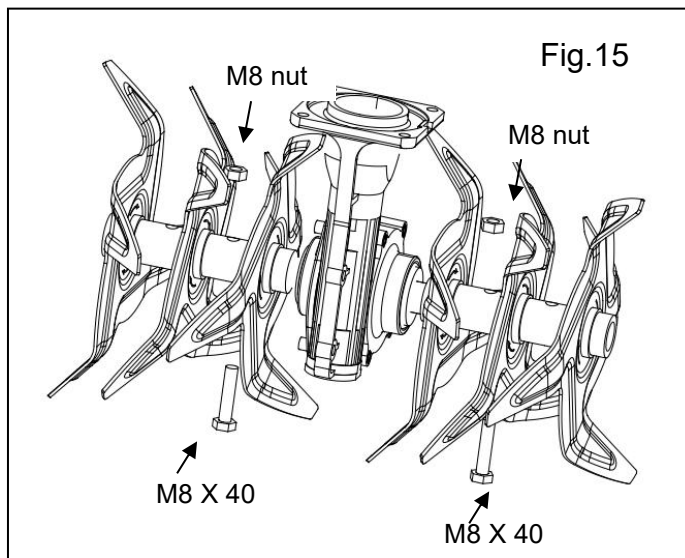
Clean the underside of the motor support plate and housing around the tines with a scrub brush, and a soft cloth dampened with a mild soap and water mixture.

**Never use a water hose to clean the tiller!** To remove soil and debris from the transmission and tines, use a stiff brush or a dampened cloth. Clean the vents on the motor housing and remove any remaining grass or dirt. Once cleaned, wipe the tines and shaft dry and apply a light coat of oil to prevent rust.

### Tines Removal and installation (Fig. 15):

Worn tines invite poor performance and overload of the motor. Check tines before each use.

Sharpen or replace the tine assemblies with new ones when necessary. Call our customer service help line.



**WARNING: Injury can occur while working on the tines. Wear protective gloves.**

To remove the complete tine assemblies from the shaft, remove the M8 X 40 hex head bolt from the shaft. Remove the tine assembly from the shaft. Reverse above steps to install tines.

### Adding Transmission Lubricant (Fig. 16):

Drain screw plug is located on the right side of transmission housing. Lay the tiller on its left side and clean the transmission of dirt and debris prior to removing the drain screw plug. If necessary, remove tine assemblies to have better access to the drain screw plug. Use a 5mm hex key to unscrew the plug.

Empty the oil from the transmission. Fill with a high-quality SAE 30 weight oil, until it begins to seep out around the hole. Reinstall the drain screw plug.

Replace worn or damaged parts with original replacement parts only. Parts from another tiller/cultivator may not fit properly causing an unsafe situation.

Make sure all protective devices are secure and in good condition. Repair or replace if necessary.

## STORAGE

**Store the Tiller in a dry, clean area out of reach of children.**

During extended periods of storage, ensure that the tiller/ cultivator is protected against corrosion and frost.

At the end of the season, or if the tiller is not being used for longer than a month, wipe over all metal surfaces with an oil impregnated cloth to protect them from corrosion or spray with a fine coat of oil. Fold the guide bar down, and store the tiller in a suitable place.

## 7. TROUBLESHOOTING

	Defective cable	Check cable. Repair or replace if required

	Overheat protection activated	1. Working depth too large, set to a shorter depth. 2. Blades blocked, remove the blockage. 3. Soil too hard, select correct work depth and move forward and backward several times while slowing down the operation speed. Wait until the motor cools down for about 15 minutes before further use.
Abnormal noises	Blade is jammed	Switch off. Wait till tines come to a complete stop. Remove jammed objects.
	Lubrication running out	Tiller must be repaired. Call our customer service help line.
	Bolts, nuts or other components are loose.	Tighten all components. Arrange for repair if noises continue.
Abnormal vibrations	Blades damaged or worn	Replace damaged or worn blades.
	Working depth too large	Set to correct working depth.
Poor results	Working depth too small	Set to correct working depth.
	Worn blades	Replace damaged or worn blades.

- Breakdowns related to carburetion beyond 90 days and fouling of carburetors.
- Periodic and standard maintenance events.

- Replacement of consumables.
- The use of non-original parts.
- Breakage of parts following impacts or projections.
